Subject:- Payment of Dearness Allowance @ 31% to Haryana Government employees w.e.f. 1st July, 2021.

The Governor of Haryana is pleased to enhance the Dearness Allowance payable to Haryana Government employees, who are drawing their pay as per 7th Pay Structure, from existing rate of 28% to 31% of the basic pay with effect from 1st July, 2021.

2. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.






