**Subject:- Revised rates of Dearness Allowance to Haryana Government employees w.e.f. 1<sup>st</sup> July, 2021.**

I have been directed to invite your kind attention towards Finance Department's earlier instructions No.4/1/2009-5FR(FD)/8101 dated 6<sup>th</sup> July, 2020 vide which instalments of Dearness Allowance to Haryana Government employees due from 01.01.2020, 01.07.2020 and 01.01.2021, were frozen and to say that **Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees shall be enhanced from the existing rate of 17% to 28% of the basic pay with effect from 1<sup>st</sup> July, 2021.**

2. The increase subsumes the additional instalments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Allowance for the period from 01.01.2020 till 30.06.2021 shall remain at 17%. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. The provisions contained in para 3,4,5, & 7 in FD's instructions No.4/3/2016-5FR/35222 dated 25<sup>th</sup> November, 2016 shall continue to be applicable while regulating Dearness Allowance under these instructions.
