In pursuance of the decision taken by the Finance Committee/Board of Management vide item No F-6/B-14 in their 19<sup>th</sup> / 22th meetings held on 23.05.2018/17.07.2018 respectively. The Vice-Chancellor is pleased to implement the following schemes for the direct benefit of Scheduled Castes (UG, PG, Diploma).

## (A) Purchase of books and membership of professional societies:-

i) Every Undergraduate and diploma student of the University belonging to SC category will be eligible for the following grants for purchase of books:

(a)	For Boys	₹ 2,000/- per year per student
(b)	For Girls	₹ 3,000/- per year per student

ii) Every Postgraduate student belonging to SC category will be eligible for the following one time grant for purchase of books and/or membership of professional societies:-

(a)	Master Program (For Male)	@Rs. 8,000/- per students for the entire
		program
(b)	Master Program (For Female)	@Rs. 12,000/- per students for the entire
		program
(c)	Ph. D. Program (For Male)	@Rs. 10,000/- per students for the entire
		program
(d)	Ph. D. Program (For Female)	@Rs. 15,000/- per students for the entire
		program

- iii) The books will be purchased through LUVAS Book Shop on the recommendations of HOD/Dean concerned (for PG and UG students)
- iv) An M.V. Sc. or Ph.D. student belonging to SC category, if becomes a Member of Professional Society, on the recommendation of HOD concerned, his actual membership fees will be reimbursed by the University through Dean PGS.
- v) The total cost of books and membership fees of Professional Societies shall not exceed the prescribed limit for each student as given in table above item A (ii).

vi) A student who has availed the benefit of the scheme during M.V.Sc. program in the University will also be eligible to avail this facility if he/she joins the Ph.D. program also in the University.

## (B) Participation of SC students in Seminars /Conference etc.:-

Ph.D. students belonging to SC category who has been allowed, on the recommendation of the HOD concerned, to participate in any academic Seminar / Conference / Workshop / Training pertaining to his/her discipline anywhere in India , once in academic year, will be eligible for reimbursement of Registration Fee and TA/DA as admissible to Senior Research Fellowship.
