**Agenda Item No.60 RIC-3: Draft for Transcript, Provisional Degree Certificate (PDC) and Degree Certificate for M.Tech. programme**

**Agenda Item No.60 RIC-5: Proposed amendment in Rule 11(11.1) of Chapter III of University Calendar Volume II.**

The PG students often apply for Make-up Examination for Mid-term and end-term examinations. The Make-up Examination fee has not been revised since long. In view of this, proposed amendment in **Rule 11(11.1) of Chapter III of University Calendar Volume II** is as under:

Rule No.	Existing Rule	Proposed Rule
11 (11.1)	The student missing an examination (mid-term and end-term) may apply for permission for make-up examination, along with a fee of Rs. 200/- per course, except in the case of request under rule 11.1(v) clearly stating reasons for missing the examination to the Dean PGS through the Major Advisor and HoD within three days of the completion of the regular examination.	The student missing an examination (mid-term and end-term) may apply for permission for make-up examination, along with a fee of Rs. <b>1000/-</b> per course, except in the case of request under rule 11.1(v) clearly stating reasons for missing the examination to the Dean PGS through the Major Advisor and HoD within three days of the completion of the regular examination.
