In pursuance of the decision taken by the Academic Council vide Agenda Item No. 64A-6 in its 64th meeting held on 16.09.2023, **Dr. Sangeeta Das**, Admn. No. **2020V19D**, a Ph.D. student in the Department of **Veterinary Microbiology** is hereby allowed to discontinue her Ph.D. after completion of 4 semester of her study (i.e. **1st semester of academic year 2022-23**) under Rule 27.2 (a) (i) of Chapter III of University Calendar Volume II after joining service as **Veterinary Officer in Animal Husbandry and Veterinary Deptt., Govt. of Assam**.
