- The candidates have to report for counselling /documents checking and other admission formalities on 19/10/2023 at 09:30 am in ABT-Lecture Room (Near Veterinary Auditorium), LUVAS, Hisar and shall have to pay fees and other charges there and then. The candidates reporting late may lose their right of admission.*
- All the candidates are required to bring all the original documents, two recent passport size photos and two sets of self-attested photocopies of documents etc. as per rule 3.12 chapter III of the Prospectus at the time of document checking, failing which he/she shall be refused admission.*
- The candidates will deposit the fees in the form of Demand Draft in favour of "Director, IPVS, LUVAS, Hisar Payable at any scheduled bank at Hisar. Fees is to be submitted in the O/o Director, IPVS on the same day i.e. 19.10.2023 after medical fitness test.*

- The candidates are advised to visit the University website before reporting for documents checking /fees submission/registration for any change.*

### Note:-

- 1 First of all, preference will be given to those candidates who have not been allotted seats in previous counselling after that remaining seats will be available for all candidates.*
- 2. In case, candidates are not available in one particular block of BC category, the seats shall be filled up from the candidates of other block as per the prospectus.*



3. Where a seat set aside for candidate from deprived Scheduled Castes for admission is not filled up due to nonavailability of candidates of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.
4. If reserve category seats still remain vacant due to any reason, the same will be filled up by the combined merit of the candidates on the same day.
5. "The Following fee/funds will not be charged from the students of Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in DVLТ course of IPVS, LUVAS:
  - i. University Admission Fee
  - ii. College Development Fund
  - iii. College Admission Fee
  - iv. Examination Fee
  - v. Laboratory Fee
  - vi. Tuition Fee
  - vii. Amalgamated Fund


However, the eligible SC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in DVLТ course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2023) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

Fees and dues at the time of admission for SC students who are eligible for Post Matric Scholarship is: Boys and Girls- Rs. 3470/-

Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
