- The number of vacant seats as stated above may increase and the final number of vacant seats will be announced on 31.10.2023 before start of counselling.
- 2. \*In the event of the quota reserved for persons with disability remaining unutilized due to non-availability of suitable handicapped candidates, it may be offered

preferably to the Ex-servicemen and their wards and the dependents of freedom fighters in that order to the extent of 1% each to these categories on 31.10.2023.

3. \*\*In case the seats remain vacant in NRI/Kashmir Migrant Category due to non-availability of eligible candidates, one seat will be filled up by the wards of regular employees of LUVAS (preferably by the ward of deceased employee who dies inservice) and remaining vacant seats in these categories will be filled up after conversion to the State Quota seat(s) as per roster/reservation policy on 31.10.2023. Therefore, all categories candidates are advised to attend the counselling.

4. In case, the candidates are not available in one particular block of BC, the seats

shall be filled up from the candidates of other block of BC on 31.10.2023.

5. Where a seat set aside for candidate from deprived Scheduled Castes for admission is not filled up due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes on 31.10.2023.

6. Seat reserved for any category in State quota still remains vacant that shall be converted to open (General) quota and shall be filled up on the basis of combined

merit list on 31.10.2023.

7. The vacant seats of VCI quota, if any, at COVS, LUVAS, Hisar and IIVER, Bahu Akbarpur, Rohtak will be converted after last date of VCI counselling i.e. 06.11.2023 as per University Rules and will be filled up in Mop-Up Counselling. The date of Mop-Up counselling will be announced in due course of time.

# Read following instructions carefully:

(i) All the eligible candidates who have applied at LUVAS for admission to B.V.Sc.&A.H. programme in COVS, LUVAS, Hisar and Affiliated Private Colleges, can participate in the counselling scheduled on 31.10.2023. However, the candidates who were allotted seat in 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> online counsellings but failed to report or complete other admission formalities etc., will not be allowed to participate in 4<sup>th</sup> counselling (Physical) to be held on 31.10.2023. However, such candidates may participate in Mop-Up counselling (if any).

(ii) The candidates have to report for Counselling and other admission formalities on 31.10.2023 at 9:30 am in the Veterinary Auditorium, COVS, LUVAS, Hisar and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant. The candidates reporting late may lose their right of admission.

(iii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-IV of the Prospectus, at the time of document checking,

failing which he/she shall be refused for admission.

(iv) The candidates who have already been admitted, are allowed for sliding from one college to another or within college from Management quota seat to State quota seat and vice-versa based on their merit and eligibility. However, the candidate should be present on the day of the counselling along with the original fee receipt. The fee already submitted by such candidates will be adjusted in the fee of same or another college. However, the candidates have to pay the difference of fee, if any, on the same day.

(v) The candidates claiming reservation under BCA/BCB categories are required to submit latest category certificate along-with latest Income Certificate issued on or after 01.04.2023 by the competent authority at the time of document checking, otherwise their candidature for admission will

not be considered.

(vi) The candidates may deposit the fees in the form of Demand Draft in favour of "Dean, College of Veterinary Sciences, LUVAS, Hisar" payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, COVS on 31.10.2023.

However, the eligible SC category students will pay the security and remaining charges at the time of admission.
