In the evolving circumstances, considering the representation of students of 4th year (batch 2019) of B.V.Sc.&A.H. programme studying in IIVER, Bahu Akbarpur, Rohtak supported by considerable facts and evidences, a number of representations in support of their demands from various authorities and directions from department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, GOI, the following decisions have been taken:

- a) Extra classes for the students of 2019-20 batch (4th year) of B.V.Sc.&A.H. programme studying in IIVER, Bahu Akbarpur, Rohtak, will be conducted w.e.f. 12.03.2024 at LUVAS campus to cover up the pending syllabus and attendance. The schedule of the classes, to be undertaken for completion of 75% attendance, will be displayed on the Notice Board of Dean, COVS, LUVAS, Hisar in due course of time.
- b) The current attendance status as provided by IIVER, Bahu Akbarpur, Rohtak will be displayed on the Notice Board by the Dean, COVS, before start of the classes. The students with attendance below 75% in any course must attend these classes to meet the requirement for examination eligibility. However, it will be ensured that whole syllabus is covered. No further opportunities for attendance coverup will be provided and no request in this regard will be entertained.
- c) Both theory as well as practical annual examinations of the students of 2019-20 batch (4th year) of IIVER, Bahu Akbarpur, Rohtak will be conducted at LUVAS, Hisar campus and admit card of the students will be issued by COE/Registrar, LUVAS.
- d) The students have to deposit bank guarantee as per orders dated 09.02.2024 of Hon'ble Punjab & Haryana High Court in CM-2040-CWP-2024 in CWP-3039-2021 before appearing in the examinations. The orders dated 09.02.2024 are reproduced hereunder:

"As an interim measure, to balance equities, the fee demanded by the petitioner-Institute through its notice dated 19.01.2024 shall remain stayed. However, the same shall be subject to submission of bank guarantees by or on behalf of the students with the petitioner-Institute equivalent to 2/3rd of the demand raised through the aforesaid notice. The bank guarantees to be
