No. 2/173/2023-1HB-III.— The State Government has decided to revise the list of chronic diseases issued vide instruction no. 2/640/2003-1HBIII, dated 08.06.2005 for the purpose of medical reimbursement. The revised list of chronic diseases is tabulated as below:-

18	Any other medical condition/ disease	Any other medical condition of chronic nature, certified by duly constituted Medical Board of AIIMS Delhi or PGIMER Chandigarh and counter signed by Director/Medical Superintendent of such institute, shall also be considered as chronic disease.

The terms and conditions laid down in the Reimbursement Policy w.r.t. Chronic Diseases issued *vide* letter no. 2/54/2020-1HB-III dated 14.07.2020 and amendment dated 06.07.2021 shall remain same and **this will come into force with immediate effect.**
