In compliance with the office order circulated by the Director, ICAR vide F.No:5/14/2020-EQR (e-80728), dated 10.08.2024, a committee was constituted by the registrar vide office order Endst. No. Reg./A-1/2024/783-87, dated 03.02.2024 under the chairmanship of Dean, PGS to submit its recommendation on the matter of relaxation in residential requirement and adoption of multiple entry/exist options as per National Education Policy 2020.

In this regard, committee submitted its recommendation to office of registrar vide No. LUVAS/PGS/PA/2024/839+E, dated 06.04.2024. The recommendation of committee was placed before the worthy Vice Chancellor by the registrar for consideration and acceptance of the same.

In view of the above, the Worthy Vice-Chancellor has approved the same with the remarks that for award of PG Diploma, the student should have passed not less than 30 credit hours including all major core-courses and compulsory credit course(s). Therefore, in view of the position explained above, the proposed amendments in relevant rules of **chapter III and III A of University Calendar Volume II** are as under:

### (b) Provision of re-entry option for the students of Ph.D. Programme

- Any student willing to re-enter (i) Ph.D. programme has to submit an application to the Dean, Post-Graduate Studies through Major Advisor and HoD at-least 15 days before the commencement of next semester. The student has to submit an affidavit clearly justifying the gap period and clearly mentioning the activities he/she was involved in during discontinued the period (Appendix-IX). In case, the applicant has joined any service, he/she has to produce the NOC the with from employer permission for completion of Ph.D. Programme and he/she will be allowed to re-join service after submission of thesis.
- (ii) Dean, PGS on the recommendations of the Major Advisor and concerned Head of the Department will take appropriate decision before the beginning of the next semester.
- (iii) The total duration of degree shall not exceed the total prescribed duration for Ph.D. study and five year of gap/discontinuation period.
- (iv) Once permitted he/she will follow all the rules and regulations as applicable to Ph.D. degree programme.
- (v) The Dean, PGS after proper verification that the student meets the eligibility for re-entry, will place an office order, intimating the HoD and other concerned offices. The student will deposit fees and other dues for the ensuing semester.
- **Note:** All the rules applicable to Ph.D. students regarding payment of stipend or any other financial

assistance and all other rules shall be applicable to students who opt for discontinuation from Ph.D. Programme.

### 21.2 For Master's students

# (a) Provision of mid programme exit option for the students

- (i) Any student can withdraw during any semester (after successful completion of the First Semester of his/her studies) due to any of the personal reasons (Including financial/medical/familial). For this, he/she has to submit an application to the Major Advisor. The fees and other dues paid by the student will not be refunded. In case of service matter, the student should intimate the University within three days of joining the service, if student fails to intimate the University within stipulated period, he/she may submit the special request for permission to join the service and to drop/exit his/her studies to the Dean, PGS through Major Advisor and the HoD with valid justification alongwith a late fee of Rs. 1000/- per day from the date of joining service.
- (ii) The Dean, PGS on the recommendations of the advisor and concerned Head of the Department will decide accordingly.
- (iii) A student, if does not wish to complete Masters' degree can be given option of Award of Post Graduate (PG) Diploma (In his/her major subject) after fulfilling the requirements mentioned under Rule 21.2(b).
- (iv) A Master's student appointed as Junior Research Fellow at the LUVAS / Institute having MoU with LUVAS and the student is carrying out research work in collaboration with same institute may be permitted to join the same, if the fellowship is in the same discipline, after completing course requirements, without dropping the studies. A Master's student can work as Junior Research Fellow for a maximum
