2. 3. The Director, IPVS wrote to the Sehrawat College of Veterinary Sciences, VPO Hathin, Palwal to fulfil the deficiencies observed by the Inspection Committee. The college sent the compliance report which was examined by the Inspection Committee. The Committee verified the compliance but was of the opinion that the

same may be physically verified by the competent authority. The house proposed that the temporary affiliation to the Sehrawat College of Veterinary Sciences, VPO Hathin, Palwal may be granted only after physical verification of fulfilment of the deficiencies pointed out by the Inspection Committee to the Office of the Director, IPVS. Thereafter, the case for temporary affiliation to run VLDD programme for the academic session 2024-2025 by Sehrawat College of Veterinary Sciences, VPO Hathin, Palwal will be put up in the next meeting of the BOS for reconsideration.

4. The house also agreed to grant temporary affiliation to IIVER, Bahu Akbarpur, Rohtak to run VLDD programme for the session 2024-25 as per rule no. 5(i) of the Norms, Procedure and Guidelines of Diploma Courses.

Agenda Item No. 7. Regarding grant of temporary affiliation to Bhumika College of Veterinary Science & Research Center, Mahendergarh for B.V.Sc. & A.H. programme for the academic year 2024-25.

An agenda item regarding grant of temporary affiliation to Bhumika College of Veterinary Science & Research Center, Mahendergarh for B.V.Sc. & A.H. programme for the academic year 2024-25. received from the Registrar, LUVAS was discussed. The inspection committee inspected the facilities created by the college for the 2nd year B.V.Sc. & A.H. programme and submitted the report. Most of the deficient documents as pointed out by the

inspection committee in their report in respect of faculty members have been provided by the college to the Registrar office and seen by the inspection committee members present in the meeting. As per rule mentioned in the agenda by the Registrar office the selection committee for the recruitment of teaching posts at affiliated private colleges should have Vice-Chancellor's nominee however, the rule is silent about the other members of the selection committee. Based on the inspection report and record available in the office of the Registrar, VC nominee is not there in the selection committee for the appointment of Dean. However, for the other teaching staff recruitment, VC nominee was member of the selection committee in most of the appointments. Hence, it was decided that college shall appoint Dean and other deficient faculty with proper procedure at the earliest and should fulfil the other deficiencies as mentioned in the inspection report.

It was pointed out that Dr. Hitesh Purohit and Dr. Dhaval Kumar Faljibhai Chaudhary appointed as Assistant Professor in the Department of Animal Genetics and Breeding are not NET qualified. Therefore, they are not eligible for the post of Assistant Professor.

Hence, it was resolved that the college may be granted temporary affiliation for B.V.Sc. & A.H. programme for the academic year 2024-25 subject to the condition that the college shall submit the compliance report regarding fulfillment of deficiencies which are still deficient (as pointed out by the inspection committee in their report) one month prior to the start of Academic Session 2024-2025, which will be examined by the inspection committee. An affidavit in this regard may be obtained from the college by the O/o Registrar.


