- (ii) The selected candidates have to report for document checking and other admission formalities on **18.09.2024 at 9:30 am** in the Veterinary Auditorium, COVS, LUVAS, Hisar and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant.
- (iii) All the candidates at the time of document checking are required to bring all the original documents, two recent photos and two sets of self-attested photocopies of all the documents as per rule 3.12 of Chapter-III of the Prospectus, failing which he/she shall be refused for admission.
- (iv) The candidate claiming reservation under BCA/BCB categories are required to submit the category certificate along-with latest Income Certificate issued on or after 01.04.2024 by the competent authority. Similarly, EWS category candidates are required to submit the latest income and asset certificate issued by the competent authority on or after 01.04.2024.
- (v) The candidates may deposit the fees in the form of Demand Draft in favour of “**Dean, CoDST, LUVAS, Hisar**” payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, CoDST on 18.09.2024.
