Important Instructions:

- (i) The seats in online counselling (1st & 2nd Counselling) will be allotted strictly as per preference(s) given by the candidate in application form.
- (ii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission.
- (iii) At the time of documents checking, the selected candidate has to give his/her consent in written whether he/she wants to participate in subsequent online counselling or not.
- (iv) The candidates who have already been admitted, are allowed for sliding in upward movement of their preference(s) from one college to another or within college from Management quota seat to State quota seat and vice-versa based on their merit and preference(s) given in the application form, in the subsequent online Counselling provided he/she had given his/her consent in written for participation in subsequent counselling. In case of sliding, the candidate should be present on the day of the counselling along with the original fee receipt of the college allotted in previous counselling. The fee already submitted by such candidates will be adjusted in the fee of same or another college. However, the candidates have to pay the difference of fee, if any, on the same day.
- (v) Once, a candidate is allotted a seat in a college and the candidate fails to deposit the fee and complete other admission formalities, he/she will be debarred for subsequent online counselling(s). However, such candidates may participate in physical & Mop-Up counselling.
- (vi) If seat reserved for any category remains vacant due to non-availability of the candidate of the same category, then the seat will be filled in the physical counselling scheduled before the Mop-up counselling by converting the same on the spot as per rules mentioned in the prospectus 2024-25.

In case, if the seat still falls vacant in any category after the last physical counselling before the Mop-Up Counselling, then one more opportunity will be given to the candidate(s) of the same category in the Mop-up counselling who has/have not been admitted at any college in previous Counsellings. Thereafter, if the seat(s) remain(s) vacant in any category, will be converted as per rules mentioned in the prospectus on the same day of Mop-Up counselling.

- (vii) Any candidate who has taken admission in COVS, LUVAS, Hisar or any affiliated private colleges will not be allowed in Mop-Up Counselling. If a candidate wants to cancel his/her admission, he/she has to submit a request in the o/o Registrar, LUVAS, Hisar, atleast one day prior to Mop-Up counselling, failing which he/she will not be allowed to participate in Mop-Up counselling.
