Important Instructions:

- (i) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-III of the LUVAS, Hisar's Prospectus, at the time of document checking, failing which they shall be refused admission.
- (ii) The candidates claiming reservation under BCA/BCB categories are required to submit category certificate alongwith latest Income Certificate or latest category certificate issued on or after 01.04.2024 by the competent authority at the time of document checking, otherwise their candidature for admission will not be considered.
- (iii) If a candidate fails to deposit the fee and complete other admission formalities, he/she will lose the right to admission at RPS COVS. However, such candidates may participate in Mop-Up counseling on 15.10.2024.
- (iv) If seat reserved for any category remains vacant due to non-availability of the candidate of the same category at Physical counselling on 10.10.2024, then the seat will be filled in the mop-up counselling scheduled on 15.10.2024 by converting the same as per rules mentioned in the LUVAS, Hisar prospectus 2024-25.
- (v) Any candidate who has taken admission in COVS, LUVAS, Hisar or any affiliated private colleges will be allowed in Mop-Up Counselling on the condition that he/she has to cancel his/her admission from the previous college and he/she has to submit a request in the o/o Registrar, LUVAS, Hisar, atleast oneday prior to Mop-Up counseling.
- (vi) If any seats remains vacant in the mop-up counseling due to non-availability of candidates B.V.Sc& A.H. aspirants who have participated in the NEET (UG) 2024 but did not apply for

admission through LUVAS, Hisar will be allowed to participate in the Mop-up physical counseling (15.10.2024). Such candidates have to pay an application fee of Rs. 14,000/- regardless of the category on the same day.

- (vii) **For counseling at RPS COVS the candidates may deposit the fees in the form of Demand Draft in favour of "RPS Education Society Veterinary College" payable at any scheduled bank at Mahendergarh or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the Accounts Office, RPSCOVS.**
