IMPORTANT:

1. The sealed packet(s) containing the papers will be delivered to the Examination Superintendent by the COE, which shall be opened in the examination hall in the presence of Invigilator(s) just before the start of the examination.
2. The practical examination should be conducted as per the norms prescribed in University Calendar Vol-II. **Each practical paper should be conducted for a total of 60 marks with a weightage of 20 each. In case of VCP-II, it will be of 100 marks with a weightage of 50 (see Annexure)**
3. The Supplementary Practical Examination shall be conducted by the Board of Examiners consisting of the concerned Head of the Department and respective instructor(s). They shall allot marks to the candidates appearing in the examination according to their performance and the marks-sheet so prepared shall be signed by instructor(s) and HoD. The complete details of Supplementary Practical Examinations should be maintained in the tabulated form showing the marks obtained by the students under different heads


like experiment/viva-voce/quiz/practical note book/written component, etc. and the same is to be submitted to the office of COE, LUVAS, Hisar along-with the attendance and result within two days after the completion of practical examinations of that paper. The detailed record of the quiz, spottings, experiment, etc. (as mentioned above) of all the students is also to be submitted to the office of COE.

4. The concerned Head of the Department and Course Instructor(s) shall review the question paper(s) on the day of examination in COE office 30 minutes before the start of Examination. Any correction / discrepancy in the question paper in respect of Syllabus noticed will be conveyed to the Controller of Examinations, who will make the required changes / corrections in the question paper and communicate the same to the external examiner.

For the smooth conduct of the Supplementary Examinations:

1. **List of the Superintendents, Invigilators and Attendants will be intimated separately.**
2. Name of the substitute for Supdt. or Invigilator(s) if any, is to be intimated in writing to this office. No change will be allowed on verbal basis.
3. Since the attendant will have to clean the seats, etc., he/she may be directed to reach the examination centre atleast 30 minutes in advance, otherwise his/her attendance will not be marked and no remuneration will be paid to him / her.
4. **The staff on duty during Supplementary Examinations will be paid the remuneration as per the approved rates.**
5. The Control Room will be in COE office.
6. **HoD and the Course Instructor(s) must reach the CONTROL ROOM atleast 30 minutes before the start of examination to review the question paper on the day of examination.**
7. Attendance-sheet, Important Instructions for Invigilator / Superintendent, Proforma for reporting unfair-means cases etc. will be available in the Control Room.
8. The Superintendents / Invigilators are requested to read the Important Instructions (to be available in the Control Room) before the start of the Examination and conduct the examination as per Instructions please.
9. **Please ensure that the invigilators are on duty for the entire duration of the examination and no laxity may be there in invigilation duty.**
10. **Please ensure that mobile phones of the invigilators and other staff are switched off during the invigilation duty. The same are to be deposited with the Superintendent please.**
11. As per Rule No. 14(26) of Chapter-II of University Calendar Vol. II, a candidate, who is late beyond 15 minutes shall not be allowed to appear in the examination. However, justification for coming late shall be examined by the Superintendent whose decision shall be final.
12. Further, as per Rule No. 14(27) of Chapter-II of University Calendar Vol. II, no candidate will be allowed to leave the examination hall before half time after the commencement of examination.

13. Students are not allowed to keep mobile phones / calculators / digital smart watches / any other electronic device with them in Examination Hall, otherwise a case of use of unfair means will be registered against them.
14. **Students without valid admit card are not allowed to appear in the examination.**

For Veterinary Clinical Practices-II (0+6) of Fourth Professional B.V.Sc.&A.H.

The examination will consist of the following components

- i) Submission of 10 complete cases each of Surgery, Medicine, Gynaecology and review of treatment of 5 cases : (at least 1 case from each section i.e. Surgery, Medicine and Gynaecology) **15+5 = 20 marks** ii) Case presentation in any of the above disciplines: Oral presentation of a case in class in presence of concerned teacher(s) : **10 marks**
iii) Written Objective Questions (Surgery, Medicine, Gynaecology and Lab Diagnosis):
15×4 = 60 marks iv) Viva-voce **10 marks**

**Addition of Note (6) under Rule 12 of Chapter-II in University Calendar
Volume-II**

The following addition of Note at Sr. No. 6 of Rule 12 of Chapter-II in University Calendar Volume-II is approved:

The teacher(s)/ evaluator(s) for internal theory assessment and annual theory and practical examinations (for VCI Regulations 2016) shall award the marks as per weightage up to one decimal digit (without rounding off). Thereafter, the marks shall be rounded off to the next half mark (e.g. 20.01, 20.10 shall become 20.5 and 20.51, 20.60 shall become 21.0) at the time of final totaling during result preparation of theory and practical examination separately.
