Read Following Instructions/Rules Carefully:

- (i) Those candidates who have already taken admission in IPVS, LUVAS, Hisar or any other Private Affiliated Colleges/Institutes will not be eligible for mop-up counselling. If such candidate want to participate in mop-up counselling, then he/she has to cancel his/her admission, and he/she has to submit a request in the o/o Director, IPVS, LUVAS, Hisar at least one day prior (27.12.2024 up to 4:00 pm) to mop-up counselling, failing which he/she will not be allowed to participate in mop-up counselling.
- (ii) **No sliding will be allowed in mop-up counselling scheduled on 28.12.2024.**
- (iii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission.
- (iv) The candidate must deposit the fee and complete other admission formalities on the same day, otherwise he/she will lose his/her right of admission.
- (v) **The reserved seats for any category will be filled-up in the mop-up counselling by candidates of the same category upto 11:00 am and in case, if the seats still remain vacant in any category, then those will be filled by converting the same as per rules mentioned in the prospectus 2024-25. This will be done on the spot in the same mop-up counselling after 11:00 am.**
- (vi) For mop-up counselling at IPVS, LUVAS, Hisar the candidate may deposit the fee in the form of Demand Draft in favour of Director, IPVS, LUVAS, Hisar payable at any scheduled bank at Hisar.

Note:

- (i) "The Following fee/funds will not be charged from the students of Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in VLDD programme of IPVS, LUVAS:
- University Admission Fee
 - College Development Fund
 - College Admission Fee
 - Examination Fee
 - Laboratory Fee
 - Tuition Fee
 - Amalgamated Fund

However, the eligible SC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in VLDD programme.


- Haryana Domicile Certificate
- Latest Income Certificate upto 2.5 Lakhs per annum
- Aadhar Card
- SC Certificate

- v. Undertaking (Annexure-XXII) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."

**Fees and dues at the time of admission for SC students who are eligible for Post Matric Scholarship is:
Boys and Girls- Rs. 3870/-**

- (ii) Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
