IMPORTANT :

1. The concerned Head of the Department and Course Instructor(s) shall review the question paper(s) on the day of examination in the Examination Hall 30 minutes before the start of Examination. Any correction / discrepancy in the question paper in respect of Syllabus noticed will be conveyed to the Controller of Examinations, who will make the required changes / corrections in the question paper and communicate the same to the external examiner.
2. The sealed packet(s) containing the papers will be delivered to the Examination Superintendent by the COE, which shall be opened in the examination hall in the presence of Invigilator(s) just before the start of the examination.

3. The practical examination should be conducted as per the norms prescribed in University Calendar Vol-II. Each practical paper should be conducted for a total of **60 marks with a weightage of 20 each.**
4. The Annual Practical Examination shall be conducted by the Board of Examiners consisting of the concerned Head of the Department and the respective instructor(s). They shall allot marks to the candidates appearing in the examination according to their performance and the marks-sheet so prepared in e-Governance system shall be signed by the examiner(s) and HoD. The complete record of practical examination should be prepared in the tabulated form showing the marks obtained by the student under different heads like experiment / viva-voce / quiz / written component / practical note-book etc. and all the record of practical examination including answer-sheets will be sent to the office of COE alongwith the result and attendance of practical examination.
5. The detailed record of the quiz, spottings, experiment, etc. (as mentioned above) of all the students is also to be submitted to the office of COE.

Note: Enter the marks of the Paper-I and Paper-II Practical examinations in the E-Governance system of LUVAS, take the print out of sheet generated in E-Governance system showing the marks of both papers separately. Get the signature of examiner(s) and HOD (with stamp and date) on the E-governance generated award list and send the award list to COE office within two days of the examination conducted.

For the smooth conduct of the External Examinations:

1. **List of the Superintendents, Invigilators and Attendants will be intimated separately.**
2. Name of the substitute for Supdt. or Invigilator(s) if any, is to be intimated in writing to this office. No change will be allowed on verbal basis.
3. Since the attendant(s) will have to clean the seats, etc., he/she may be directed to reach the examination centre atleast 30 minutes in advance, otherwise his/her attendance will not be marked and no remuneration will be paid to him / her.
4. **The staff on duty during External Examinations will be paid the remuneration as per the approved rates.**
5. The Control Room will be in the O/o COE LUVAS, Hisar.
6. **HoD and the Course Instructor(s) must reach the CONTROL ROOM atleast 30 minutes before the start of examination to review the question paper on the day of examination.**
7. Attendance-sheet, Important Instructions for Invigilator / Superintendent, Proforma for reporting unfair-means cases etc. will be available in the Control Room.
8. The Superintendents / Invigilators are requested to read the Important Instructions (to be available in the Control Room) before the start of the Examination and conduct the examination as per Instructions please.

9. **Please ensure that the invigilators are on duty for the entire duration of the examination and no laxity may be there in invigilation duty.**
10. **Please ensure that mobile phones of the invigilators and other staff are switched off during the invigilation duty. The same are to be deposited with the Superintendent please.**
11. As per Rule No. 14(26) of Chapter-II of University Calendar Vol. II, a candidate, who is late beyond 15 minutes shall not be allowed to appear in the examination. However, justification for coming late shall be examined by the Superintendent whose decision shall be final.
12. Further, as per Rule No. 14(27) of Chapter-II of University Calendar Vol. II, no candidate will be allowed to leave the examination hall before half time after the commencement of examination.
13. Students are not allowed to keep mobile phones / calculators / digital smart watches / any other electronic device with them in Examination Hall, otherwise a case of use of unfair means will be registered against them.
14. **Students without valid admit card are not allowed to appear in the examination.**
15. **Further, if a student is having less than 50% attendance in any of the subject, he/she will not be issued Admit Card to appear in external examinations.**
