Kindly refer on the subject cited above.

I have been directed to inform you that AYUSH Department has decided to empanel the following private Hospital under AYUSH Medical Reimbursement Policy on the basis of submission of application along with NABH Accredited Ayurvedic Hospital Certificate as per Policy. The Reimbursement rates of expenditure incurred for treatment on indoor basis shall be on NABH rates and as per scope of services to the Haryana Govt. Employees / Pensioners and their dependents:-

2. To provide seamless and hassle-free services to Haryana Govt. Employee/Pensioner's and their dependents, the empaneled private AYUSH Hospitals shall extend all normal courtesies and facilities, the admission, treatment and discharge of Haryana Govt. beneficiaries with no delay and denial of medical facility.
3. A Nodal Officer shall be appointed at the level of empaneled private AYUSH Hospital. The Nodal Officer will communicate with department in case of any grievance.
4. In case of any emergency/disasters/overflow of patients in Govt. Hospital during epidemics the empaneled hospital will agree to share their Ambulances, Mortuary, ICU, Burn Unit, Ward Beds etc. in need base manner.
5. All statutory Rules/Guidelines/Acts/Notifications issued State Govt. from time to time (as mentioned in Memorandum) shall be followed by the empaneled private AYUSH Hospital.

6. The above listed NABH Accredited Ayurvedic Hospital will remain empaneled for period of three years subject to validity of accreditation certificate. Thereafter, the Hospital will apply fresh.
7. AYUSH Department reserves the right to call for- record of treatment of any patient from empaneled hospital to ensure no mal-practice takes place.
8. The above mentioned empaneled private AYUSH hospital will maintain record of the treatment of the patients.
