The counselling schedule for admission to M.V.Sc. and Ph.D. programme for the 2nd semester of Academic year 2024-25 was circulated by the office of Dean, PGS vide No. LUVAS/PGS/Acad/2025/4646, dated 07.03.2025 and same was uploaded on university website for information of all the applicants and other stakeholders.

It is pertinent to mention here that one seat has been reserved for ESM/FF candidates in General category as per roster during the academic year 2024-25 and same will be filled from the ESM/FF candidate of General Category from Haryana residents.

Inadvertently, ESM/FF candidates have been called for counselling on 17.04.2025 along with ICAR/ICCR nominee/NRI/RVC etc. As per LUVAS prospectus 2024-25, one seat for ESM/FF candidates has been reserved from the General Category of Haryana resident for admission to M.V.Sc. programme, therefore, ESM/FF candidates are to be called for counselling on **19.04.2025** along with other Haryana resident candidates.

Further, the counselling schedule mentioned on **Sr. No. i of (A)** in already circulated counselling schedule for ICAR candidates only may be carried out on **16 & 17.04.2025** instead of **17.04.2025** to accommodate the marriage date of one of the candidates..
