**Subject: Norms, Procedure and Guidelines for affiliation of institutions offering
/desirous of starting Veterinary and Livestock Development (VLD)
Diploma course in the State of Haryana, with effect from academic session
2015-16.**

- 1) Institutions offering VLD diploma (VLDD) course, in the state of Haryana, shall follow the procedures and guidelines laid down by the Institute of Para Veterinary Sciences (IPVS), Lala Lajpat Rai University of Veterinary and Animal Sciences (LUVAS), Hisar (Haryana) in order to maintain uniformity and to ensure high quality of training.
- 2) An institution desirous of starting the diploma course shall have to first obtain “No Objection Certificate” (NOC) from the Government of Haryana, Animal Husbandry & Dairying Department. *The NOC is only an in principle permission of the state government to approach LUVAS for affiliation and does not confer any legal right on any institution to be affiliated to the University unless it is found to be fulfilling all the eligibility conditions prescribed for such affiliation.*
- 3) After obtaining the NOC, the institution shall have to apply (Application form as in annexure 3) to the Director, IPVS, LUVAS within 120 days of obtaining the NOC for pre- affiliation inspection of the institution which is intended to evaluate infrastructural, technical, clinical, academic and financial capability of the institution seeking affiliation in keeping with the requirements prescribed. The applicant institution shall not start any academic activity including advertisement for admission under any circumstances before getting the affiliation from LUVAS. The institution shall be required to deposit along with the application, initial affiliation fee of Rs. 3,50,000/- (Rupees three lakh fifty thousand only) and an inspection fee of Rs. 70,000/- (Rupees seventy thousand only) in the form of Demand Draft in favor of Director IPVS, payable at Hisar. The University will exercise control over the institution/college as per Norms, Procedure and Guidelines for affiliation of a private institute/ College for starting VLD diploma course in the State of Haryana.

The pre-affiliation inspection has to be necessarily carried out before 31st March provided the application along with required fee has been deposited latest by 28th February of the current year. 2nd Inspection may, if required, be done before the start of academic session. The affiliation will be subject to recommendations by the Inspection Committee to be constituted by Director, IPVS, LUVAS with the approval of Vice-Chancellor, LUVAS. The Inspection Committee will have two members from faculty of different departments of COVS of the rank not below Associate Professor /equivalent and member/s from the state government, if any. Each member will be from separate department. The senior most faculty member of the Inspection Committee will act as Chairman and the junior most will act as Member-Secretary. One Inspection Committee will inspect at the most three private VLDD institutions/colleges in a calendar year. Honorarium to members of

inspection committee will be provided by the University as per rates approved from time to time. The Committee shall submit its report to Director, IPVS. The Director IPVS shall submit the report to the Board of Studies of the concerned constituent college for deliberation. The Board of Studies will submit the report to the Affiliation Committee along with its recommendations and the affiliation committee shall examine and place it before the Academic Council for decision. Renewal of affiliation in subsequent years will be subject to the recommendations by the Inspection committee as prescribed in rule 4 which shall visit the institution before 30th April of that year.

- 4) The Inspection Committee will inspect premises/facilities and all the documents pertaining to the financial strength, infrastructural facilities, clinical, academic and technical capabilities of the institution. The institution shall beside demonstration of adequate financial strength, furnish a bank guarantee of Rs. 50,00,000/- (Rupees fifty lakhs only) in favor of Director, IPVS, within two months of start of academic session. In case the affiliated institution fails to complete the course after having started the same, the money in the form of bank guarantee shall be forfeited by the Director, IPVS. The bank guarantee of Rupees Fifty lakhs deposited by the affiliated Institutes will be retained by the Director, IPVS, LUVAS for a period of five years after the first batch of VLD diploma students admitted through LUVAS has passed out, and thereafter the bank guarantee of Rs 50,00,000/- (Rupees fifty lakhs only) will be reduced to Rs 10,00,000/- (Rupees ten lakhs only) for colleges which come under Schedule-I of VCI Act 1984; whereas, it will be reduced to Rs 20,00,000/- (Rupees twenty lakhs only) for colleges which do not come under Schedule-I of VCI Act 1984. The bank guarantee will be got renewed every year before the start of Academic Session.

However, the inspection shall be as under:

- i) For colleges, which come under Schedule-I of VCI Act 1984, inspection shall lay off, unless warranted.
 - ii) For colleges, which do not come under Schedule-I of VCI Act 1984, subsequently to the period of five years after the first batch of VLD diploma students admitted through LUVAS has passed out, inspection will be after every two years, chargeable as per existing rules.
- 5) The renewal of affiliation in subsequent years will be subject to the recommendations by the Inspection Committee as prescribed in rule 4, which shall visit the institution before 30th April of that year. The institution shall have to deposit an inspection fee of Rs. 70,000/- (Rupees seventy thousand only) by 28th February every year. The institution shall not issue any advertisement for admission pertaining to concerned academic year before the renewal of affiliation.
- 6) Academic standards with respect to quality of teaching and the minimum essential infrastructure such as laboratories, lecture halls, sports ground, computer lab, multimedia lab, teaching animal farm and clinic etc. shall be governed by the Director, IPVS, LUVAS as per requirements given in Annexure-1.

- 7) Intake capacity for VLD diploma course shall be a maximum of 60 students per year or as approved by the LUVAS.
- 8) Admission to VLD diploma course in the affiliated institutions will be on the basis of an Entrance Test conducted by the Director, IPVS, LUVAS, Hisar. Students desirous of seeking admission under state as well as management quota in an affiliated institution shall have to apply to the Director, IPVS, LUVAS for admission as per procedure given in the Diploma Prospectus of that particular academic year.
- 9) Process of Registration and Counselling for admission to VLD Diploma in the affiliated institutions will be online/offline & fees is to be deposited in the account of Director, IPVS, LUVAS Hisar as per prospectus uploaded at LUVAS website.
- 10) Fee for students admitted to affiliated institutions shall be fixed as per procedure laid down or notified by the Govt. of Haryana.
- 11) Admission process for the diploma course must be completed before 30th September of each academic year and no admission will take place after this date. The academic calendar as prescribed by the Director, IPVS, LUVAS, Hisar and instructions/clarifications on it issued by the University shall be followed by the affiliated institutions.
- 12) Annual theory examination of all the VLDD courses (LUVAS campus and affiliated Institutes/colleges) will be conducted by Controller of Examination, LUVAS at the Centre(s) fixed by LUVAS, Hisar. Annual practical examination of all the VLDD courses will be conducted by the respective Institutes/Colleges at their own campus; however, surprise checks for monitoring the proper conduct of practical examinations will be done by the Director of Institute of Para Veterinary Sciences. The date sheet of examination for both theory and practical will be prepared by the COE in consultation with Director, IPVS which will be uniformly followed by the Institutes/Colleges. Compiled results along with record of theory and practical examinations will be submitted to the Director, IPVS within a week after the end of examination by the In-charge, VLDD Section of LUVAS/ Principal/ Dean of Constituent/Affiliated Institutes/ Colleges.
- 13) Diploma certificates shall be issued on successful completion of the course by Director, IPVS, LUVAS, Hisar to the students of constituent college(s) as well as to the students of the institute(s)/college(s) affiliated to LUVAS.
- 14) Norms Procedure and Guidelines as framed by the Board of Studies, College of Veterinary Sciences, LUVAS, Hisar and approved by Academic Council, LUVAS, Hisar shall also be applicable to the students of the affiliated institutions/college.
- 15) Minimum faculty strength for a diploma course for a batch up to 90 (ninety) students shall be one Principal, four faculty members as Veterinary Surgeons

(Veterinary Graduates) and one English teacher. Minimum faculty strength for a diploma course for a batch up to 120 (One hundred and twenty) students shall be one Principal, eight faculty members as Veterinary Surgeons (Veterinary Graduates) and one English teacher. The qualification will be as mentioned below:

i) The Principal must be appointed on a full-time basis and possess a Masters' degree (M.V.Sc) in any discipline of Veterinary Sciences/ M.Sc. in any subject of Animal Science (Animal Genetic & Breeding, Animal/Livestock Products Technology, Animal Production Physiology, Animal Nutrition, Animal Feed Technology, Livestock Production Management) with a minimum of 10 years' experience in teaching, research, extension or field service. The upper age limit shall be 70 years.

ii) Veterinary Surgeons shall be appointed on a full-time basis and the upper age limit shall be 70 years. He/ she should possess a minimum of B.V.Sc.&A.H. degree.

iii) The English teacher may be appointed on a full time or contractual basis and the upper age limit shall be 70 years. He/ she should possess at least a second class postgraduate degree in English.

iv) The faculty/staff shall be recruited before inspection of the institute/ college by LUVAS, after proper advertisement at least in one national daily newspaper, through the Selection Committee, which shall include nominee of Director IPVS as member (Professor / equivalent). The private college/institute will provide the complete advertisement copy to the University along with the request to nominate the Director's nominee at least 10 days before the interview. Seating charges for each interview day (offline/online) and transport facilities shall be provided by the private institute/college to the Director's nominee in selection committee for recruitment of faculty as per University approved rates. The University may amend seating charges with passage of time.

v) The society/ trust of the affiliated institution/ college shall be required to provide the record of Principal, faculty members, English teacher and staff viz., academic qualifications, relevant experience, copy of appointment orders, declaration from the faculty engaged by the applicant body as per prescribed format (Annexure 2) and other details for record in the office of Director of IPVS, minimum 30 days before the first counselling as per the counselling schedule notified by Director, IPVS, LUVAS. If Principal, any faculty member, English teacher or staff resigns or joins, the information must be furnished within 15 days to the Director, IPVS, LUVAS, Hisar.

vi) Where the institute is imparting both B.V.Sc. & A.H. degree and VLD diploma, Principal of the college/Director, IPVS may utilize services of faculty recruited for B.V.Sc. & A.H. programme to teach courses of VLDD, in addition to four/eight VLDD faculty members.

- 16) The affiliated college/institution shall have its in-house well equipped functional clinics with adequate manpower. If the in-house clinic does not fulfil the requirement, then the affiliated institution/college will have to make arrangements for attachment of its students to suitable Government Veterinary Hospital(s) and get the same approved by the University provided the number of outdoor cases in such hospital(s) are having an average of not less than 10 outdoor clinical cases per day for a period of one year.

- 17) It shall be the sole responsibility of the applicant society to satisfy the requirements and follow all directives of LUVAS, Government of Haryana or any such authority. The University shall only be acting as a facilitator, without any legal, financial or consequential liabilities arising out of the matters connected with affiliation.
- 18) If at any time during the continuation of affiliation, the Government of Haryana, LUVAS or any other authority raises any objections or makes any observation in view of the requirements or any other law, it shall be mandatory on the part of the institute/college to take immediate remedial measures and to report the action taken to the concerned authority after compliance.
- 19) Any punitive/ suggestive/ advisory action by the University/ Govt. of Haryana shall be binding on the institution/college. University affiliation or any other action shall not override the issues raised by the University/ Govt. of Haryana etc.
- 20) The University may appoint such number of visitors/ inspectors, as it may deem necessary to inspect any aspect of the affiliated institution/college without any prior notice. The visitors/ inspectors shall have the powers for photography/ videography / seeking required documents like pay slips of staff, appointment letters, advertisements for recruitment of faculty and other staff, leave records of faculty and staff, bills of various purchases & attendance records etc., but may not interfere with the conduct of any training or examination. Inspection report shall be submitted to the Vice-Chancellor through the Director, IPVS, LUVAS, Hisar.
- 21) The University shall be empowered to institute an enquiry into the affairs related to academics/ admissions/ examinations/ affiliation/ appointments and any other matter, of the affiliated institution/college for which it shall be mandatory for the affiliated institution/college to provide the required information and extend cooperation.
- 22) Atrocity on women, SC/ST or minority and grievances of faculty/ staff/student:

Affiliated institutions/colleges shall have a cell to address the atrocities, if any, on women, persons belonging to SC/ST or minorities category as per the guidelines of Hon'ble Supreme Court/ Govt. of Haryana. The affiliated institutions/colleges will also have a committee to resolve the grievances of faculty/ staff/ student. Report of any such action by the college/institute shall be submitted to the Director, IPVS, LUVAS, Hisar for information and necessary action.
- 23) Powers to withdraw affiliation:

The affiliation granted to a private institution/ college can be withdrawn temporarily or permanently at any time by the University as and when violation of any provisions of the rules, guidelines, instructions or notifications issued by the University/Government of Haryana or any other appropriate authority comes to the notice of LUVAS, Hisar. The University may take any of the following action:
 - i) Warning to the institutions/colleges to implement expeditiously the directions/ instructions/ guidelines of the University/ Government of

Haryana.

- ii) Financial fine up to a maximum amount of Rs. one lakh.
- iii) Temporary withdrawal of affiliation.
- iv) Withdrawal of affiliation (permanent).

Note:

- (i) A committee consisting of the following will decide regarding the actions to be taken:
 - (a) Director, IPVS, LUVAS - Chairman
 - (b) Comptroller, LUVAS - Member
 - (c) One HOD to be nominated by Dean COVS, LUVAS – Member
 - (d) Representative of the Vice-Chancellor- Member
- (ii) Before taking any action under the above sub sections, a reasonable opportunity of being heard shall be provided to such institution/college by the above Committee. The recommendations of the Committee will be submitted to the Vice-Chancellor for necessary action.

- 24) Restoration of Affiliation of a Veterinary institution/college whose affiliation has been withdrawn temporarily:

An institution/college whose affiliation has been withdrawn temporarily shall not be permitted to admit students for any of the academic years until such time that its affiliation is restored by the university.

An application, along with the required fee as prescribed in Rule 3, may be made for restoration of temporarily withdrawn affiliation to the Director IPVS of the university by furnishing a commitment as may be necessary for the removal of deficiencies/ objections which have formed the basis of withdrawal of affiliation and the affidavit mentioned shall be signed by the Chairman or member of the governing body of the institutions/colleges duly authorized in this regard. In case of temporary withdrawal of affiliation, bank guarantee submitted by the institute will stand in the name of institute.

- 25) Liability of University in case of permanent withdrawal of affiliation:

Candidates shall be taking admission in private institutions/colleges at their own risk without any liability, financial or otherwise, on the part of the affiliating University or the State Government. The private institutions/colleges will ensure that the candidates and their parents are informed well in advance. In case of permanent withdrawal of affiliation, the students studying in an affiliated institution /college will be shifted as per the decision of the University to other affiliated institutions/colleges. The bank guarantee of the institution/college pledged with LUVAS will stand forfeited. However, the shifted students shall be liable to pay the fee and other charges of the institutions/colleges to which they have been shifted.

In case of permanent withdrawal of affiliation, the institutions/colleges shall have to apply afresh as prescribed in rule 2.

- 26) No suit, prosecution or other legal proceedings shall lie against the University or State Govt. or any officer or employee or any other person authorized by the State Govt./the University for anything which is done or intended to be done in good faith under these guidelines or the notifications

issued their under by the University from time to time.

27) RTI Act-2005

The applicant body/institute/ college shall be bound to implement the provisions of RTI Act -2005 and operate in a transparent way with respect to all affairs of the college. Name and address of the State Public Information Officer and Appellate Authority to fulfil obligations under the Right to Information Act, 2005, is to be furnished to Director, IPVS, LUVAS within 120 days of start of first Academic Session.

28) Redressal of Grievances

A committee of the following will be constituted by the Vice-Chancellor of the University for receiving and enquiring into the grievance(s) of the students or teachers and other staff of the said college/institute:

- a) Director, IPVS- Chairman
- b) Dean, COVS, LUVAS- Member
- c) Vice-Chancellor's nominee- Member
- d) Two Professors/Associate Professors of LUVAS (one female) - Junior of them will be Member-Secretary

29) Jurisdiction: Jurisdiction for all the disputes will be at Hisar.

Note: The institutes already affiliated with COVS Hisar shall stand transferred to IPVS and they would be required to obtain renewal of affiliation from IPVS w.e.f. academic session 2015-16.

Annexure-1

Requirement of land / building Infrastructure consisting of Administrative Block, Academic building, Hostels, Veterinary Hospital, Livestock farm etc., shall be as per guidelines given below:

INFRASTRUCTURE:

The standards of infrastructure for the affiliating institutions running VLD diploma course are:

1. Requirement of land
 - (a) For college/ institutions imparting diploma course only:
Minimum ten acres of land on long term lease or ownership in the name of institution.
 - (b) For affiliated college/ institutions imparting B.V.Sc. & A.H. degree and diploma courses both:
Minimum land as per MSVE Regulations for B.V.Sc. & A.H. degree programme.
2. Constructed buildings:
 - A. Administrative Block:
 - a. 300 square feet carpet area for academic head of the institution.
 - b. 250 square feet carpet area for the office of the supporting staff.
 - c. 500 square feet carpet area as a reception place.
 - d. 200 square feet carpet area for the store.
 - e. Separate toilets for staff, students and girls/ladies.
 - B. Academic Block including labs. and library:
 - a. 150 square feet carpet area for each faculty member.
 - b. 3000 square feet carpet area for the library.
 - c. 1200-1500 square feet carpet area each for two lecture halls (up to 90 students) and four lecture halls (up to 120 students) preferably fitted with audio visual aids and CCTV cameras with internet Wi-Fi facility.
 - d. 1200-1500 square feet carpet area each for two laboratories (up to 90 students) and four laboratories (up to 120 students) with CCTV cameras.
 - e. 3000 square feet carpet area for multipurpose hall.

Note:

- i. Two sections (60 students each) will have to be formed in the colleges/institutes where the students intake capacity is 120.
- ii. Each section will have to batches of 30 students each.

C. Veterinary Hospital:

A functional in-house veterinary clinics constructed on a plot of one acre/attached Govt. veterinary hospital of the level of polyclinic/district level Govt. Veterinary Hospital having the required facilities for diagnosis and treatment of medicinal, surgical and gynaecological & obstetrical ailments in animals (Annexure 1-A). The In-charge Veterinary Clinics shall submit the certificate certifying that the students have attended the clinics along with their attendance and the work report including average count of outdoor clinical cases for a

working day, which may be verified by the University periodically.

D. Animal farm:

- a. Four acres for animal farm including fodder and pasture facilities.

The minimum number for different livestock is as follows:

- i. Cattle and Buffalo (Adult) = 20
(Minimum 5 of each species)
 - ii. Sheep & Goat = 15
(Minimum 5 of each species)
 - iii. Pig = 2
 - iv. Poultry = 150
- b. Priorities: To train the students with respect to management, nutrition and breeding activities.
- c. Personnel: Farm manager (1), Farm supervisor (1), VLDA (1), Animal attendants (minimum four), sweepers (minimum two) and chowkidar (1).
- d. Equipment: As per annexure 1-B
- e. Shed/water: As per standard requirements for the specified number of animals, there should be proper sheds and water arrangement.
- f. Circulation area: Sufficient area should be provided.

E. Standard of the laboratory attached to the Academic block:

- a. Personnel: Lab technician (1), Lab. attendants (minimum two).
- b. Equipment: As per annexure 1-C
- c. Biochemical reagents & Chemicals: As per annexure 1-D

F. Hostel & recreational facilities:

- a. Hostel must have good facilities.
- b. Accommodation for warden and deputy warden along with hostel.
- c. Student's mess and common room etc.
- d. Annual inspection report, from Fire Station of Haryana Fire and Emergency Service, for academic and hostel blocks be appended.

G. Play grounds & Recreational facilities:

Two acres area for play grounds and required facilities for sports.

Ratio of carpeted area and open and circulation area in the campus should be at least 1:1.
