

At the outset, the Chairman welcomed Dr. R.N. Chaudhary, Prof. & Head, VSR as new member to the council and wished that his contribution in the deliberation of the Council will be constructive and useful. Ratified with the following changes in the proposed amendments:

- i) The numbering of rule- 21.2 (b) at page no. A-13 will start from the 1st line instead of 5th.
- ii) The words '**officer order**' in rule-(v) of sr. no. 21.2 (b) at page no. A-14 be read as '**office order**'.
- iii) The word '**period**' be added after the word 'discontinued' in last line at page-A-15.
- iv) In rule 21.3 on page A-17, the words 'he/she' be added after the words 'In such cases, in the 6th line from the top.

However, the prospectus for B.Tech. (Dairy Technology) & PG programmes is approved with following changes:</p>

1. The important dates for B.Tech. (Dairy Technology) will be as under:
 - i) Availability of Application Form: 09.08.2024
 - ii) Last date for submission of online application form (without late fee) : 26.08.2024
 - iii) Last date for submission of online application form (with late fee) : 29.08.2024
 - iv) The Schedule of online counselling/seat allotment and other details pertaining to admission shall be displayed on the University website by 06.09.2024.
2. The candidate who suffers with any kind of mental disability shall not be allowed for admission to B.Tech. and PG programmes. The necessary changes in this regard are to be incorporated under the heading 'Definition of persons with Disability' in the prospectus.
3. The instructions regarding creamy layer mentioned in the prospectus shall be changed as per Gazette Notification No. 40/13/2024-1SW dated 16.07.2024 issued by Department of Social Justice, Empowerment, Welfare of Scheduled Castes And Backward Classes And Antyodaya (Sewa).
4. The word "CCSHAU, LUVAS" in third line of page no. A-219 be read as "CCSHAU/LUVAS".
5. The Academic Calendar of B.Tech (Dairy Technology) be removed from the prospectus 2024-25.
