1. The important dates for B.V.Sc.&A.H. programme will be as under:

05.09.2024

ii) Last date for submission of online application form (without late fee) :  
20.09.2024

iii) Last date for submission of online application form (with late fee):  
23.09.2024.

2. Photo(s) are to be removed except front page. Page numbering in the index will be changed accordingly.

3. Admissions at IIVER, Bahu Akbarpur, Rohtak are subject to final outcome of Court case no. CS/608 of 2024 in Civil Court, Rohtak.


4. As per guidelines issued by Veterinary Council of India (VCI) vide letter no. 1535-37 dated 20.08.2024, the Merit List of NEET Qualified should be considered for admission (except NRI). The necessary changes in the prospectus will be made accordingly.
5. The candidate who suffers with any kind of mental disability shall not be allowed for admission to B.V.Sc.&A.H. programme. The necessary changes in this regard are to be incorporated under the heading 'Definition of persons with Disability' in the prospectus.
6. The instructions regarding creamy layer mentioned in the prospectus shall be changed as per Gazette Notification No. 40/13/2024-1SW dated 16.07.2024 issued by Department of Social Justice, Empowerment, Welfare of Scheduled Castes And Backward Classes And Antyodaya (Sewa).
7. The Fee Structure of affiliated private colleges is to be added in the prospectus as per State Govt. Memo No. 4251(CFMS)-AH-4-2024/4823 dated 21.08.2024. Alumni Fee is also to be added however, same will be refunded to the student on his request upon cancellation of his/her admission before completion of degree.
