At the outset, the Chairman, welcomed all the Hon'ble members and special invitees and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and decision taken thereof:

- Agenda Item No. 73 RIC-3:** Amendment in LUVAS Prospectus 2025-26 (UG and PG Programmes) regarding seats of Haryana residents for admission to M.V.Sc. programme in 1st and 2nd semester of the Academic Year 2025-26.

The Prospectus for UG and PG programmes of LUVAS for the academic year 2025-26 was approved by the Academic Council in its 72nd meeting held on 05.07.2025 and 19.07.2025 vide Agenda Item No. 72A-3. In the approved prospectus 2025-26, the discipline wise number of seats to be filled from Haryana residents for admission to M.V.Sc. programme are mentioned in table given under rule no. 6.1 of Chapter V of Prospectus 2025-26. As per prospectus 2025-26, admission to M.V.Sc., M.Tech. and Ph.D. programmes will be done in both semesters of 2025-26. The admission forms for the 1st semester will be available on the university website from 25.08.2025 to 20.09.2025 and for the 2nd semester, date of availability of admission forms will be announced in the month of February/March 2026.

Now, some B.V.Sc. & A. H. students of COVS, LUVAS have submitted an application in which they stated that their internship is scheduled to be completed in March 2026. Since counselling for 1st semester will be held in month of October 2025, they are not eligible for admission to M.V.Sc. programme in 1st semester of academic year 2025-26, with the justification that majority of the LUVAS passouts will not get chance to get the M.V.Sc. seats if all the seats are filled in the 1st semester.

In view of the above, the seats to be filled from Haryana residents for admission to M.V.Sc. programme may be fixed separately for 1st and 2nd semester of academic year 2025-26. In this context, it is proposed that 40%-50 % seats be fixed from Haryana residents for 1st semester, 2025-26 and rest of seats for 2nd semester, 2025-26. Further, the seats remaining vacant after counselling for 1st semester for admission to M.V.Sc. programme will be filled in the 2nd semester, 2025-26 along with seats fixed for 2nd semester.

In the light of the facts mentioned above, the table given under rule no. 6.1 of chapter-V of prospectus 2025-26 regarding number of seats for Post-Graduate Programme in College of Veterinary Sciences may be amended.


As per proposed amended table given under rule 6.1 of Chapter-V of prospectus 2025-26, one seat each in discipline of Veterinary Biochemistry and Veterinary Anatomy for admission to M.V.Sc. programme may be increased. Therefore, distribution of seats for M.V.Sc. programme mentioned in table under rule 7 of Chapter-V of Prospectus 2025-26 may be replaced as under.


