At the outset, the Chairman, welcomed all the Hon'ble members and special invitees and wished that the contribution of members in the meeting will be constructive and useful.

Thereafter, the following agenda items were discussed and decision taken thereof:

- Agenda item No.74 RIC-1:** **Confirmation of the proceedings of the 73rd meeting held on 12.08.2025.**

- Agenda item No.74 RIC-2:** **Action taken report on the proceedings of 73rd meeting held on 12.08.2025.**
Noted and approved
- Agenda Item No. 74 RIC-3:** **Exemption in processing fee for equivalence certificate in respect of Foreign Nationals and NRI.**

Four foreign candidates (3 for M.V.Sc. and 1 for Ph.D.) applied for admission to M.V.Sc. and Ph.D. Programmes on Study in India (SII) portal. They have attached their educational documents and some other essential documents at the Study in India portal.

As per provision contained under rule 1.7 of Chapter V of LUVAS Prospectus 2025-26, admission of Foreign Nationals nominated by ICAR-DARE/ICCR/Govt. of Haryana will be made on recommendation of equivalence committee of LUVAS. Further, they are required to obtain the requisite equivalence certificate form the Registrar, LUVAS by paying a non-refundable processing fee of **US \$450** or equivalent in Indian Currency, in cash or in the shape of Bank Draft as mentioned under rule 5.19 of Chapter V of LUVAS Prospectus 2025-26.

It is pertinent to mention here that there is no provision mentioned in CCS HAU Prospectus 2025-26 regarding processing fee in lieu of Equivalence Certificate for the Foreign Nationals.

Since limited time is available before the commencement of the 1st semester 2025-26, a temporary exemption of the fee of US \$450 (or equivalent in Indian currency) may be granted to Foreign Nationals and NRI in lieu of the Equivalence Certificate, as provisional Admission Acceptance Letters need to be uploaded on the Study in India Portal for the eligible candidates.

Subsequently, in case the foreign students join their studies on the recommendation of ICCR/ICAR/Government of Haryana/Government of India with

suitable scholarships and NRI candidates if any, a non-refundable processing fee of US \$450 (or equivalent in Indian currency) will be charged at the time of Registration in addition to the regular/normal fees.

In addition to the above, it is proposed that Equivalence Committee constituted for B.V.Sc. & A. H. for the academic year 2025-26 may also be adopted for PG programmes for the academic year 2025-26.

The RIC discussed the matter at length and recommended that:

- 1. A temporary exemption in processing fee of US \$450 or equivalent in Indian currency may be granted in respect of Foreign Nationals and NRI if any. However, this fee may be charged at the time of Registration in addition to the regular/normal fees from the candidate who secure admission in the LUVAS for the Academic Year 2025-26, based on recommendation of ICCR/ICAR/Govt. of Haryana/Govt. of India.***
- 2. The Equivalence Committee constituted for B.V.Sc. & A.H. for the academic year 2025-26 may also be adopted for PG Programmes for the same academic year.***

Further, the RIC recommended to place the matter before the worthy Vice-Chancellor for seeking approval subject to the ratification by the Academic Council in its ensuing meeting.

The meeting ended with a vote of thanks to the Chair.


