NOTICE

It is hereby notified that the Government of India, Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, Krishi Bhawan, New Delhi has not issued "Letter of Permission" (LoP) to Bhumika College of Veterinary Science and Research Centre, Mahendergarh for the academic year 2025-26 subsequently the Lala Lajpat Rai University and Animal Sciences, Hisar has also not granted affiliation to the said institute for the academic year 2025-26.


As per communication received from the Veterinary Council of India (VCI) vide letter dated 08.09.2025, the VCI has decided as under:

1. "To recommend to the Central Government for transfer of students admitted during the academic sessions 2023-24 and 2024-25 in Bhumika College of Veterinary Science and Research Centre, Mahendergarh, affiliated to LUVAS, Hisar, to another recognized veterinary college under the University as provided under Rule 9(12) read with Rule 19(1) of VCI Rules, 2017.
2. To direct the affiliating University (Lala Lajpat Rai University of Veterinary and Animal Sciences, Hisar) not to make any admissions to the B.V.Sc. & A.H. course at aforesaid veterinary college for the academic session 2025-26 until and unless, Central Government issue the renewal of Letter of Permission in respect of said veterinary college."

In view of above communication received from Veterinary Council of India, the matter was placed before the Academic Council of the University vide agenda item No. 76A-2 held on 04.10.2025 and following decision was taken:

1. The candidates who have applied to LUVAS for admission to the B.V.Sc. & A.H. programme for the academic year 2025-26 are informed that admission to Bhumika College of Veterinary Science and Research Centre, Mahendergarh shall be allowed only after receipt of renewal of LoP from the Central Government and grant of temporary affiliation from LUVAS for the academic year 2025-26.

2. Already admitted students during the academic session 2023-24 and 2024-25 in B.V.Sc.&A.H. programme at Bhumika College of Veterinary Science and Research Centre, Mahendergarh are advised not to deposit any fee for registration to the next class until the Central Government issues the renewal of LoP for the said college and grant of temporary affiliation from LUVAS for the academic year 2025-26.
