(iv). Mop-Up counselling (if any): The schedule will be displayed on University Website after 3<sup>rd</sup> counselling.

#### **Important Instructions:**

- (i) All candidates (except NRI category) seeking admission to B.V.Sc. & A.H. programme of COVS, Hisar as well as affiliated private colleges must have qualified in the NEET (UG)-2025 conducted by National Testing Agency (NTA) and the seats in counselling will be allotted strictly as per merit based on score obtained by the candidate in NEET(UG)-2025.
- (ii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-III, of the Prospectus and failure to produce any of the original documents shall make the candidate ineligible for the admission. The candidates who intend to seek admission in LUVAS and have deposited their original documents in other institute for admission, are required to bring original fee receipt and written statement of that institute that his/her original documents are retained with the institute at the time of document checking and such candidates have to bring two sets of photocopies of original documents and other essentials with them.
- (iii) The candidates who have already been admitted, are allowed to slide from one college to another or within college from Management quota seat to State quota seat and vice-versa based on their merit, in the subsequent Counselling. In case of sliding, the candidate should be present on the day of the counselling along with the original fee receipt of the college allotted in previous counselling. The fee already submitted by such candidates will be adjusted in the fee of same or another college. However, the candidates have to pay the difference of fee, if any, on the same day. No sliding will be done in Mop-up (Final) counselling (if any).
- (iv) The candidates claiming reservation under BCA/BCB categories are required to submit category certificate along-with latest Income Certificate issued on or after 01.04.2025 by the competent authority. However, the candidate who possess a valid category certificate issued on or after 01.04.2025, indicating non-creamy layer status are not required to upload or produce a separate income certificate. Similarly, the EWS category candidates are required to submit the latest income and asset certificate issued by the competent authority on or after 01.04.2025.
- (v) If seat reserved for any category remains vacant due to non-availability of the candidate of the same category, then the seat will be filled during 3<sup>rd</sup> counselling by converting the same on the spot as per rules mentioned in the prospectus 2025-26.

In case, if the seat still falls vacant in any category after the 3<sup>rd</sup> counselling, then one more opportunity will be given to the candidate(s) of the same category in the Mop-up counselling (if any) who has/have not been admitted at any college in previous Counsellings. Thereafter, if the seat(s) remain(s) vacant in any category, then the vacant seat(s) will be filled up by converting the same as per rules mentioned in the prospectus 2025-26 on the same day of Mop-Up counselling (if any).

- (vi) Any candidate who has taken admission in COVS, LUVAS, Hisar or any affiliated private colleges will not be allowed in Mop-Up Counselling (if any). If a candidate wants to cancel his/her admission, he/she has to submit a request in the o/o Registrar, LUVAS, Hisar, atleast one day prior to Mop-Up counselling, failing which he/she will not be allowed to participate in Mop-Up counselling (if any).
- (vii) The candidates are advised to read the prospectus 2025-26 and website notices carefully for further details/Instructions regarding admission to B.V.Sc&A.H. programme 2025-26.
- (viii) The candidates are advised to keep visiting the University Website i.e. <a href="https://www.luvas.edu.in">https://www.luvas.edu.in</a> for latest updates.
