It is hereby notified for information of all candidates seeking admission to B.V.Sc.&A.H. programme at LUVAS for the academic session 2025–26 that the following amendments in the University Prospectus 2025-26 for B.V.Sc&A.H. programme are hereby made:

5(i) of Chapter-III.	The NRI and their children/wards only will be considered for admission under this category.	The NRI (NRIs/ Overseas Citizen of India (OCIs)/ Persons of Indian Origin (PIOs)) and their children/wards will be considered for admission under this category.
5(vii) of Chapter-III.	The admission under NRI category for the above programme is primarily for the candidates having ancestral background in Haryana provided they fulfill other conditions. However, in the event of vacant seats after admitting them, NRI candidates who have already applied from other Indian states will be considered.	<p>The Preference for admission under NRI Category shall be considered in the following order:</p> <ul style="list-style-type: none"> (i) Actual NRIs/OCIs/PIOs candidates who originally belonged to the State of Haryana. (ii) Children of NRIs/OCIs/PIOs who originally belonged to Haryana State. (iii) Actual NRIs/OCIs/PIOs who originally belonged to an Indian State and Union Territories other than Haryana. (iv) Children of NRIs/OCIs/PIOs who originally belonged to an Indian State and Union Territories other than Haryana. (v) Real brother and sister of the candidate. (vi) If the first-degree relation of the student is NRI and residing abroad and the candidate fulfils the following condition: - <ul style="list-style-type: none"> a) He should be the nearest relation. b) In the definition of nearest relation, candidate having following blood relation: - <ul style="list-style-type: none"> i) Real Brother and sister of father i.e real uncle and real aunt.

		<p>ii) Real brother and Sister of mother i.e real maternal uncle and maternal aunt.</p> <p>iii) Father and mother of father i.e. grandfather and grandmother.</p> <p>iv) Father and mother of mother i.e. maternal grandfather and maternal grandmother.</p> <p>v) First degree-paternal and maternal cousins.</p> <p>vi) Such person should be NRI.</p> <p>c)Such persons should ordinarily be residing abroad.</p> <p>d) Such person should have looked after such student as the guardian of the student and evidence to that effect must have been produced by such person.</p>
