Approved with following changes:

(i) The date of the availability of the application form at page no. 2 be replaced from "15.07.2025" to "26.07.2025". Last date of submission of application form including NRI candidates be replaced from "05.08.2025" to "14.08.2025" (without late fee) and "11.08.2025" to "20.08.2025" (with late fee).

(ii) The date of the availability of the application form at page no. 3 be replaced from "15.07.2025" to "26.07.2025". Last date of submission of application form be replaced from "05.08.2025" to "14.08.2025" (without late fee) and "11.08.2025" to "20.08.2025" (with late fee).

(iii) In rule 3.3 at page 15 a Note be added "If the seats remains vacant the directions, if any, issued by the VCI or the State Government will be followed to fill up the vacant seats".

(iv) The words "non-migrant" be deleted before the words "Kashmiri Pandits" at all the places in prospectus.

- (vii) At page no. 27 in 8<sup>th</sup> line the words "against Haryana Resident seats" be replaced with "except admitted against VCI quota".
- (viii) In rule 3.11 at page 35 the word "Senior" be replaced with word "designated" and the words "the University Hospital, CCS HAU, Hisar" be replaced with "LUVAS, Hisar".
- (ix) In rule 5.9 at page 60 the word "Senior" be replaced with word "designated" and the words "Campus Hospital of CCS HAU, Hisar" be replaced with "LUVAS, Hisar".
- (x) At page no. 63 below in Rule 5.19 (iv), the words "GOI/ICAR" be replaced with word "GOI/Govt. of Haryana/ ICAR /ICCR".
- (xi) The words "Self Attested" be deleted in the starting of check list of documents at page no. 113, 116 & 120.
- (xii) The necessary changes according to Physical Counselling be made in the prospectus.
