Proceedings of 349th meeting of BOS circulated vide letter No. VPP/BOS/2025/2434-2460 dated 28.10.2025 were confirmed.

Agenda Item No. 2. Discussion on the recommendations of the committee regarding the issue raised by Diploma Veterinary Association, Haryana on Bridge Course for Non-Science Students in the VLDD Programme.

An agenda item regarding Discussion on the recommendations of the committee regarding the issue raised by Diploma Veterinary Association, Haryana on Bridge Course for Non-Science Students in the VLDD

Programme received from O/o Registrar, LUVAS, Hisar was discussed in the house. After deliberations, the house recommended that:

- For the students admitted in the academic session 2024-25, the bridge course classes have already been conducted, so the students should be evaluated for passing the bridge course as Satisfactory (40% and above marks)/Unsatisfactory (having obtained less than 40% marks) before the commencement of academic session 2025-26.
- 2. For the students admitted in the academic session 2025-26 and onwards the bridge course classes should be run parallel to the other courses of the VLDD Programme. The students should be evaluated for passing the bridge course during the break period of First Year as Satisfactory (40% and above marks)/Unsatisfactory (less than 40% marks) before the commencement of the Annual examinations.
- 3. Those students who are declared Unsatisfactory (having obtained less than 40% marks) may be given another chance in the next year. However, if the student is not able to get satisfactory during the second year, then a supplementary examination may be arranged for such students by the Director IPVS in order to enable them to appear in the exit examination. For appearing in the exit examination, the satisfactory grade in the bridge course should be mandatory (having obtained 40% and above marks).
- The question paper for bridge course should comprise of 50 multiple choice questions from the course already prescribed for the bridge course.
- The bridge course examination will be conducted by the respective Dean/ Principal/ COE of Constituent/Private Affiliated College /Institute as per the schedule conveyed by the Controller of Examinations, LUVAS, Hisar.
