That in pursuance of the decision taken by the Board of Management, LUVAS vide agenda item No. B-8 in its 35th meeting held on 05.12.2025, the provision given under Note below clause 6 Ch-IV of LUVAS Statutes has been deleted vide Amendment No. 01/2025 issued vide notification endst. no. Admn/F-3/2025/3100-3155 dated 17.12.2025

In this regard, in order to remove ambiguity on the deletion of mandatory condition of NET for teaching posts, it is clarified that the qualifications of the teachers are in consonance with the UGC regulation issued from time to time and further, the provision governing qualifications of teachers has also been provided in Clause 6(2) of Ch-VI of Statutes. Therefore, the competent body has already framed the Model Qualification for Assistant Professor/equiv. circulated vide this office memo No. Admn./F-1/2024/1712-1751 dated 09.08.2024 and are operative(Copy Enclosed).

Hence, to avoid duplication of provisions, Note below clause 6 Ch-IV of Statutes has been deleted. It is further clarified that NET in concerned discipline shall remain a mandatory condition for the post of Assistant Professor/Equiv. subject to relaxations provided in the Model Qualifications.

Model Qualification for the post of Assistant Professor /Equivalent in LUVAS, Hisar.

In continuation to the Model Qualification for teaching posts circulated vide letter No. Admn./F-1/2024/44-83 dated 27.01.2024, the Academic Council vide Agenda item No. 69A-15 in its 69th meeting held on 03.08.2024 has approved the following revised model qualification for the post of Assistant Professor/Equivalent in LUVAS:

Assistant Professor/Equivalent

Existing Model Qualification (i) Bachelor's degree (for College of Vety. Sciences B.V.Sc. & A.H. degree recognized by VCI) with minimum 60% marks or 6.0 OGPA on 10.0 point scale or equivalent grade in a point scale where other grading

system is followed.

- (ii) Master's degree (for College of Vety. Sciences M.V.Sc. degree from University/College recognized by VCI) with minimum 70% of marks or equivalent grade in a point scale where grading system is followed in the subject/discipline concerned (to be defined)
- (iii) Must have passed NET examination in the concerned discipline/sub-discipline from ASRB (NET from UGC/CSIR where NET is not conducted by ASRB) on or before the last date of submission of application.

Approved Model Qualification

- (i) Bachelor's degree (for College of Vety. Sciences B.V.Sc. & A.H. degree recognized by VCI) with minimum 60% marks or 6.0 OGPA on 10.0 -point scale or equivalent grade in a point scale where other grading system is followed.
- (ii) Master's degree (for College of Vety. Sciences M.V.Sc. degree from University/College recognized by VCI) with minimum 70% of marks or equivalent grade in a point scale where grading system is followed in the subject/discipline concerned (to be defined)
- (iii) Must have passed NET examination in the concerned discipline/subdiscipline from ASRB (NET from UGC/CSIR where NET is not conducted by ASRB) on or before the last date of submission of application.

Provided however, that candidates, who are or have been awarded a Ph.D accordance with degree in University Grants Commission (minimum standards and procedure for award of Ph.D degree) Regulations, 2009 or the subsequent regulations, if notified by the UGC, shall be exempted from the requirement of minimum eligibility condition of NET for recruitment and appointment of Assistant Prof. or equivalent position in Universities/Colleges/Institutions. Further, the award of degree to candidates registered for M.Phil./Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/Regulations of the Institutions awarding the degree and the Ph.D candidates shall be exempted from the requirements of NET for recruitment and appointment Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfillment of the following conditions

- a) Ph.D. Degree of the candidate awarded in regular mode only.
- b) Evaluation of the Ph.D Thesis by at least two external examiners.
- c) Open Ph.D Viva voce of the candidate had been conducted.
- d) Candidate has published two research papers from his/her Ph.D work out of which at least one must be in a referred journal.
- e) Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D work.
- (iv) Hindi/Sanskrit as one of the subject upto Matric or Higher Education.
- (v) A relaxation of 5% of marks will be provided at graduation and master's level for the SC/Differently able categories candidates.
