Read Followings Instructions/Rules Careful:

- i. All the candidates who have appeared in VLDD Entrance Test-2025 are eligible for 2nd stray round counselling.
- ii. All the candidates who did not appear in VLDD Entrance Test-2025 but filled the application form are eligible for 2nd stray round counselling.
- iii. All the candidates who did not fill the application form for VLDD ET 2025 are eligible for 2nd stray round counselling by registering himself/herself on the same day by paying a registration fee of Rs. 5000/-.
- iv. Additionally, the candidates who have already applied for admission to VLDD programme will be considered first for admission, thereafter, the candidates who will get themselves registered on the spot on 30.12.2025 will be considered for admission.

- v. *Those candidates who have already taken admission in IPVS, LUVAS, Hisar or any other Private Affiliated Colleges/Institutes will not be eligible for stray-round counselling. If such candidate wants to participate in stray round counselling, then he/she has to cancel his/her admission, and he/she has to submit a request in the O/o Director, IPVS, LUVAS, Hisar at least one day prior (29.12.2025 up-to 03:00 pm) to stray round counselling, failing which he/she will not be allowed to participate in stray round counselling.*
- vi. *The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission.*
- vii. *The candidate must deposit the fee and complete other admission formalities on the same day, otherwise he/she will lose his/her right of admission.*
- viii. *For stray round counselling at Affiliated Private Colleges/Institutes the candidate may deposit the fee there and then as given below:*
