Important Instructions:

(i) The number of vacant seats may alter and the final number of vacant seats will be announced on 09.01.2026 before start of Stray Round counselling.

(ii) All candidates (except NRI category) seeking admission to B.V.Sc. & A.H. programme of COVS, Hisar as well as affiliated private colleges must have qualified in the NEET (UG)-2025 conducted by National Testing Agency (NTA) and the seats in counselling will be allotted strictly as per merit based on score obtained by the candidate in NEET(UG)-2025.

(iii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. **as per rule 3.11 of Chapter-III, of the Prospectus** and failure to produce any of the original documents shall make the candidate ineligible for the admission. The candidates who intend to seek admission in LUVAS and have deposited their original documents in other institute for admission, are required to bring original fee receipt and written statement of that institute that his/her original documents are retained with the institute at the time of document checking and such candidates have to bring two sets of photocopies of original documents and other essentials with them.

- (iv) The candidates claiming reservation under BCA/BCB categories are required to submit category certificate along-with latest Income Certificate issued on or after 01.04.2025 by the competent authority. However, the candidate who possess a valid category certificate issued on or after 01.04.2025, indicating non-creamy layer status are not required to upload or produce a separate income certificate. Similarly, the EWS category candidates are required to submit the latest income and asset certificate issued by the competent authority on or after 01.04.2025.
- (v) If seat reserved for any category remains vacant due to non-availability of the candidate of the same category, then the seat will be filled during the counselling by converting the same on the spot as per rules mentioned in the prospectus 2025-26.
- (vi) Any candidate who has taken admission in COVS, LUVAS, Hisar or any affiliated private colleges will not be allowed in Stray Round (Physical) Counselling. However, already admitted candidates may participate in the Stray Round Counselling only after getting their existing admission cancelled at least one day prior to the stray round counselling scheduled to be held on 09.01.2026.
- (vii) The candidates are advised to read the prospectus 2025-26 and website notices carefully for further details/Instructions regarding admission to B.V.Sc&A.H. programme 2025-26.
- (viii) The candidates are advised to keep visiting the University Website i.e. <https://www.luvass.edu.in> for latest updates.
- (ix) The candidates may deposit the fees in the form of Demand Draft *in favour of "Dean, College of Veterinary Sciences, LUVAS, Hisar"* payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, COVS.
