- (ii) *to assign the additional charge of vacant posts of Registrar and Comptroller beyond six months on necessity and need basis to the Deans/Directors or Senior most Professors-equiv. or Dy. Comptroller/Dy. Registrar till regular arrangements are made or till the date of their retirement or till further orders.*
- (iii) *to assign the additional charge of vacant post of HoDs and Regional Directors beyond six months on necessity and need basis to the Professor-equiv. or Associate Professor-equiv. who have not previously held the charge of Dean/Director/HoD on tenurial basis for full term of 4 years.*
