Subject: Extension of last date and revision of fee for submission of applications for Lower Standard Examination (LSE) and Higher Standard Examination (HSE) for the Year 2026

In continuation of this office Memo No. Admn./E-IV/2026/330-65+E dated 07.01.2026 and Admn./E-IV/2026/736-70 dated 21.01.2026, it is hereby informed that the last date for submission of applications for appearing in the Departmental Lower Standard Examination (LSE) and Higher Standard Examination (HSE) for the year 2026 has been extended up to 28.01.2026.

As per the approved revised guidelines dated 21.01.2026, "The employees will be allowed four (04) chances for appearing in the Lower Standard Examination and six (06) chances for appearing in the Higher Standard Examination from the year 2025-2026 and onwards.

Employees who have already availed four chances for the Lower Standard Examination and six chances for the Higher Standard Examination (in CCSHAU & LUVAS), irrespective of whether such chances were availed as paid or free, will be required to deposit an examination fee of ₹500/- (Rupees Five Hundred only) per paper for each subsequent appearance in the examination.

An employee who applies for the examination but fails to appear for the same for any reason whatsoever will be deemed to have availed that chance".

The fee can be deposited in this office, and the original receipt must be attached with the prescribed performa.

All other terms and conditions mentioned in the aforesaid memos shall remain unchanged.

This may be circulated among all non-teaching ministerial employees (except stenography staff) working under your control for information and necessary action.
