


Agenda Item No. 79A-2: Action taken report on the proceedings of 78th meeting of Academic Council held on 25.11.2025.

Approved with the following changes:

- i. In Rule no. 7(1) at page no. A-15 the word "private colleges" be read as "**private affiliated colleges**".
- ii. In Rule no. 11(2) at page no. A-18 the word "**only**" mentioned in 2nd line be deleted.
- iii. In Rule no. 12(iii) at page no. A-19 the word "twenty days" mentioned in 3rd line be replaced with "**the period as recommended by Officer Commanding NCC Unit**".
- iv. In Rule no. 12(vii) at page no. A-20 the word "DSW" be read as "**DSW-cum-EO**".
- v. In rule no. 28(6) at page no. A-21 the word "the affiliated college/institute" mentioned in sixth line be read as "**private affiliated college/institute**".



- vi. In Rule no. 30(e) at page no. A-22 the following addition be made at end **“after receipt of the request”**.
- vii. The Rule no. 30 (f) at page no. A-22 be deleted.
- viii. In Rule no. 17(2)(ii) note (f) at page no. A-25 the word **“worthy”** be deleted.

Agenda Item No. 79A-8: Regarding grant of temporary affiliation to Ideal Veterinary College, Singhani, Bhiwani to start B.V.Sc.&A.H. programme for the academic year 2026-27.

The Academic Council after considering the recommendations of affiliation committee has given its recommendations as under:

“Recommended to the Board of Management for grant of temporary affiliation to Ideal Veterinary College, Singhani, Bhiwani for starting the B.V.Sc.&A.H. programme with an intake capacity of 80 students annually from the Academic Session 2026-27 subject to necessary permission from Veterinary Council of India. However, the Institute will submit an affidavit to the effect that the compliance report regarding fulfilment of deficiencies as mentioned in Inspection Report will be submitted by the Institute to the University one month prior to start academic session of 1st year B.V.Sc.&A.H. programme 2026-27. Further, the compliance report will be referred to the Inspection Committee for examination before final acceptance by the University”.


