Subject: Grant of interest free Advance to Class-IV Government Employees for the purchase of Wheat during the year 2026-27.

The Worthy Vice-Chancellor, LUVAS, Hisar is pleased to grant interest free advance of ₹27,000/- to all class-IV employees in the University on the pattern of State Govt. (copy of State Govt. letter no. 46/1/2011-WM(6)/ 1557-1562 dated Chandigarh, the 16.04.2026 attached) who wish to purchase wheat for their own/their family consumption during the year 2026-27 as under :-

Sr. No.	Category	Admissibility Condition	Admissibility limit of advance and installment of recovery
1	Wheat Advance	All Class IV Govt. employees	₹27,000/- recoverable in monthly installment to be fixed by deptt. so as to effect its full recovery before the close of F.Y. 2026-27 i.e.31.03.2027

The advance will be admissible to permanent/ temporary Class-IV regular University employees only. The advance will be sanctioned by the DDO concerned. In the case of temporary employees, allow advance on the basis of surety to their satisfaction so that it is fully secured and its recovery is ensured from the loanee before the close of the financial year 2026-27.

The following conditions should be complied with while sanctioning this loan:-

- (i) A certificate must be obtained within one month from the date of drawl of the advance from the loanee to the effect that **he/she has utilized the amount for the purchase of wheat.**
- (ii) The officer concerned, before sanctioning the advance should satisfy himself/herself that the incumbent official will continue in service until full recovery of the total amount of advance is affected.
- (iii) **These orders will be cease to operate after 15th may, 2026.**
- (iv) The recovery of the first installment of the advance should preferably be made from the pay for the month of May, 2026 paid in june,2026.
- (v) The advance should not be granted to those employees who are on deputation to other Government/ Corporation and Local bodies etc.
- (vi) **The advance will not be admissible to work charged/ contingent paid staff/ daily wagers and contractual employees.**
- (vii) **Where both husband and wife are employed, the wheat advance should be allowed to only one of them. In such case, an undertaking will be submitted by officials concerned that his/her spouse will not claim the same.**

- (viii) In case of sanction of wheat advance to ineligible employee, the DDO concerned will be responsible and action will be initiated as per rules.
- (ix) **Last date of receipt of application form (copy attached) in this office is 12.05.2026. Application received after last date will not be entertained.** The entry of wheat loan of ₹27,000/- are to be recorded in ECR and Demand Collection Register and for disbursement as well as recovery of wheat loan.

This may kindly be got noted from Class-IV University employees.
