Proceedings of 2nd meeting of BOS were circulated vide letter No. Memo No. DBM/BOS/2026/311-21 Dated: 19.03.2026.



After detailed deliberations, the Board observed that since the financial year 2024-25 and 2025-26 has already been closed, processing and release of stipend pertaining to the said period is not feasible at this stage. However, for the financial year 2026-27, the Board unanimously resolved that the payment of State Share in stipend to eligible B.Tech. (Dairy Technology) students may be processed and released in accordance with the prescribed rules and proper office procedure.
