Subject: Terms & Conditions for the contract of Guava Fruit Trees at New Campus, LUVAS Hisar.

1. Contract period of Guava Orchard (450 trees) will be for next year i.e. upto 14.03.2027.
2. The university will not be responsible to provide any pesticide/insecticide transport, maintenance and loss due to any type of natural disaster during the contract period.
3. Irrigation work will be executed by the contractor.
4. During the construction work if any tree falls between construction work. The contractor will not be eligible for any claim from university.
5. Contract of Guava Orchard will be in favour to the highest bidder subject to the approval of the committee.
6. The successful bidder shall have to make 25% the payment in cash on the spot at the fall of hammer and balance 75% shall be deposited on cash within next 02 days.
7. In case of any dispute, the decision of committee will be final.
8. Committee may reject any bid without any reasons.
9. The bidder has to deposit (Cash) of Rs. 30000.00 (Rupees thirty thousand only) as earnest money, in the event of not honouring the terms of contract by successful bidder, the earnest money will be forfeited.
10. Jurisdiction of Hisar Court will apply for any legal action in court of law.
