Venue: – Veterinary Auditorium, LUVAS, Hisar (Old Campus).

- All the eligible candidates who have applied at LUVAS for admission to B.Tech. (Dairy Technology) programme in LUVAS, can participate in the Physical Counselling.
- The seat(s) reserved for any category remains vacant due to non-availability of the candidate(s) of the same category, then the vacant seat(s) will be filled-up by converting the same, on the spot, on the basis of combined merit list.
- All the candidates at the time of document checking are required to bring all the original documents, two recent photos and two sets of self-attested photocopies of all the documents as per rule 3.13 of Chapter-IV of the Prospectus, failing which he/she shall be refused for admission.
- The candidates who intend to seek admission in LUVAS and have deposited their original documents in other institute for admission there, are required to bring original fee receipt and written statement of that institute that his/her original documents are retained with the institute. Also such candidates have to bring two sets of photocopies of original documents and other essentials with them.
- The candidate claiming reservation under BC-A/BC-B categories are required to submit the latest category certificate along with latest Income Certificate issued on or after 01.04.2026 by the competent authority. However, the candidate who posses a valid category certificate issued on or after 01.04.2026, indicating non-creamy layer status are not required to upload or produce a separate income certificate. Similarly, EWS category candidates are required to submit the latest income and asset certificate issued by the competent authority on or after 01.04.2026.
- The candidates may deposit the fees in the form of Demand Draft in favour of “Dean, CoDST, LUVAS, Hisar” payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, CoDST on 16.09.2026.

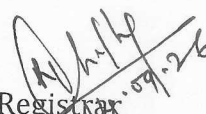
