***Important Instructions:***

- i. The number of vacant seats may increase and the final number of vacant seats will be announced on 05.11.2024 before start of Mop-Up counselling.
- ii. All the eligible candidates who have applied at LUVAS for admission to B.Tech (Dairy Technology) programme in CODST, LUVAS, Hisar, can participate in the Mop-Up counselling.
- iii. The candidates have to report for counselling and other admission formalities on **05.11.2024 at 9.30 A.M.** in the Veterinary Auditorium, COVS, LUVAS, Hisar and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant. The candidates reporting late may lose their right of admission.
- iv. **The candidates who had not applied for admission by filling application form of LUVAS but participated in JEE (MAIN)-2024 examination and obtained JEE score, are allowed to participate in the Mop-Up Counselling scheduled to be held on 05.11.2024 by paying a fee of Rs.14000/- on the day of Mop-Up counselling.**
- v. If reserved category seats remain vacant due to any reason, the same will be filled up by converting the same as per rule mentioned in the prospectus.
- vi. The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.12 of Chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission.

- vii. The candidates may deposit the fees in the form of Demand Draft in favour of “Dean, CoDST, LUVAS, Hisar” payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, CoDST on **05.11.2024**.
