Important Instructions:

- (i) The seats in online counselling (1st & 2nd Counselling) will be allotted only for IPVS, LUVAS, Hisar.
- (ii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of Chapter-III of the Prospectus, at the time of document checking, failing which they shall be refused admission
- (iii) Once, a candidate is allotted a seat in IPVS, LUVAS and the candidate fails to deposit the fee and complete other admission formalities, he/she will be debarred from 2nd online counselling. However, such candidates may participate in physical/mop-up counselling.
- (iv) In case additional seats at IPVS LUVAS (In-service, J&K residents, Kashmiri Migrants/Non-Migrant Kashmiri Pandits/Kashmiri Hindu Families, GNCT Delhi candidates, SSB, Village Riwasa resident in District Mahendergarh) still remain(s) vacant, after online counselling(s) due to non-availability of eligible candidate(s), the same will be converted in the State Quota seat(s) as per roster/reservation policy.
- (v) Those candidates who have already taken admission in any affiliated private college/institute will not be eligible for mop-up counselling of IPVS, LUVAS or any other affiliated private colleges/institutes. If such candidates want to participate in mop-up counselling, then he/she has to cancel his/her admission, and he/she has to submit a request in the o/o Director IPVS, LUVAS, Hisar at least one day prior to mop-up counselling, failing which he/she will not be allowed to participate in mop-up counselling.

(vi) For online and physical counselling(s), the candidates may deposit the fee in the form of Demand Draft in favour of Director, IPVS, LUVAS, Hisar payable at any scheduled bank at Hisar.

However, the eligible SC/DSC category students will pay the security and remaining charges at the time of admission.
