One buffalo bull No. LPM-085 will be auctioned on 24.11.2020 at 10.00 a.m. at the Buffalo Farm, College of Vety. Sciences, LUVAS, Hisar. All interested persons are requested to reach well in time to bid for animal. The auction will be conducted on the following terms & conditions.

1. The animal shall be sold by open auction.
2. The animal shall be sold to the highest bidder subject to approval of the auction committee.
3. Successful bidder shall have to make the payment in cash within 2 days after action.
4. In case of any dispute, the decision of the auction committee shall be final.
5. The animals shall have to be removed within 48 hours after the auction is over failing which the bidder will have to pay Rs. 100/- per day per animal towards feeding charges. After ten days of auction if successful bidder fails to remove the animals from the farm, the animal will be put to re-auction and the amount deposited by him as earnest money shall be forfeited.
6. Committee may reject any bid without any reason.
7. The bidder will have to deposit Rs.5000/- per bid as earnest money along with attested photocopy of Aadhar card and in the event of not honoring the terms & conditions of auction by successful bidder, the earnest money will be forfeited.
8. Earnest money will be refunded on completion of auction process after verifying the identity in person.
9. The auctioned animal will be delivered to the original bidder only after verifying the identity of the original bidder.
10. Suckling calf of lactating buffalo will be given on book value with auctioned dam if demanded.
11. Jurisdiction of Hisar court will apply for any legal action in the court of law.

12. After depositing the payment, gate pass with vehicle registration number will be issued to the successful bidder by the concerned officer.

13. After successful bid and subsequent deposition of payment, there will be no responsibility of institution in case of any kind of incident.

14. All precautionary measures for containment of COVID-19 will be adopted at auction site.
