"CORRIGENDUM"

In pursuance to the decision taken by competent authority of this University, it is brought to the notice of all the candidates who want to seek admission in PG programmes in LUVAS, Hisar that the distribution of seats for M.V.Sc. programme for academic year 2020-21 for scheduled castes as prescribed in the prospectus at serial no. 7, i) on page no. 24, is now amended as per notification issued by Law and Legislative Department Govt. of Haryana vide no Leg.15/2020 dated 15.05.2020. Accordingly, fifty percent of the 20% seats reserved for Scheduled Castes for admission in PG Programme in LUVAS, Hisar will be reserved for candidates belonging to deprived Scheduled Castes. Therefore, distribution of seats for M.V. Sc. Programme at serial no. 7, i) on page no. 24 in PG prospectus will be as mentioned below:



2. Relaxation in date of PDC submission for admission in PG Programmes in LUVAS, Hisar for the Academic Year 2020-21

Further, it is brought to the notice of all the candidates who want to seek admission in PG programmes that the relaxation will be given to those students who will not be able to submit their PDC till 31st December, 2020 due to delay in their internship or degree Programme. Such students are allowed to produce their PDC at the time of counselling and will be considered for admission in PG Programmes in Academic Year 2020-21. However, the last date for submission of application form will remain the same i.e. 31st December, 2020.
