IMPORTANT INSTRUCTIONS:

- All the candidates who appeared in LUVAS Entrance Test-2022 for Dairy Technology programme, are eligible to appear in physical counselling schedule to be held on **31.08.2022**.
- The candidates have to report for 2nd counselling (Physical) for vacant seats on **31.08.2022 at 9:30 AM** in the Veterinary Auditorium, COVS, LUVAS, Hisar and the selected candidate shall have to pay fees and other charges there and then, otherwise the seat will be offered to next eligible candidate in merit.
- The number of vacant seats as stated above may increase and the final number of vacant seats will be announced on **31.08.2022** before start of counselling.
- In case, the candidates are not available in one particular block of BC, the seats shall be filled up from the candidates of other block of BC on **31.08.2022**.
- Where a seat set aside for candidate from deprived Scheduled Castes for admission is not filled up due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes on **31.08.2022**.
- In case the seat(s) remain(s) vacant in J&K Residents/Kashmiri Migrants/ non migrant Kashmiri Pandits/Kashmiri Hindu Families Categories due to non-availability of eligible candidate, one seat will be filled up by the wards of regular employees of LUVAS (preferably by the ward of deceased employee who dies in-service) during physical counselling.
- In case the seat(s) still remain(s) vacant in J&K Resident/Kashmiri Migrants/non migrant Kashmiri Pandits/Kashmiri Hindu Families Categories due to non-availability of eligible candidate(s), the same will be converted to the State Quota seat(s) as per roster/reservation policy and will be filled up during 2nd counselling (physical).

- viii. Seat reserved for any category in State quota still remains vacant that shall be converted to open (General) quota and shall be filled up on the basis of overall merit list on **31.08.2022.**
- ix. The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Prospectus, at the time of counselling failing which he/she shall be refused for admission.
- x. The candidate claiming reservation under BCA/BCB categories are required to submit the latest category certificate along-with latest Income Certificate issued on or after **01.04.2022** by the competent authority. Similarly, EWS category candidates are required to submit the latest income and asset certificate issued by the competent authority on or after **01.04.2022.**
- xi. The selected candidates may deposit the fees in the form of Demand Draft in favour of "Dean, CoDST, LUVAS, Hisar" payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, CoDST on **31.08.2022.**
