### **Read following instructions carefully:**

- (i) The selected candidates are advised to download their provisional seat allotment letter from candidate login and bring one hard copy for reporting.
- (ii) The selected candidates have to report for document checking and other admission formalities on **21.10.2024 at 9:00 am** in the ABT Lecture Hall (Near Veterinary Auditorium), LUVAS, Hisar and shall have to pay fees and other charges **there and then**, otherwise the seat will be declared vacant.

- (iii) All the above mentioned candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Prospectus, at the time of document checking, failing which he/she shall be refused for admission.
- (iv) Once, a candidate is allotted a seat and the candidate fails to deposit the fee and complete other admission formalities, he/she will be debarred for subsequent online counselling(s). However, such candidates may participate in Physical/Mop-Up counselling (if any).
- (v) **The candidates claiming reservation under BCA/BCB categories are required to submit latest category certificate issued on or after 01.04.2024 by the competent authority at the time of document checking, otherwise their candidature for admission will not be considered.**
- (vi) The candidates may deposit the fees in the form of Demand Draft in favour of **“Director, IPVS, LUVAS, Hisar”** payable at any scheduled bank at Hisar.

i. “The Following fee/funds will not be charged from the students of Scheduled Castes category (only those who are eligible for Post Matric Scholarship) at the time of admission in DVLT course of IPVS, LUVAS:


- i. University Admission Fee
- ii. College Development Fund
- iii. College Admission Fee
- iv. Examination Fee
- v. Laboratory Fee
- vi. Tuition Fee
- vii. Amalgamated Fund

However, the eligible SC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Matric Scholarship (PMS) are required to submit the following documents at the time of admission in DVLT course.

- i. Haryana Domicile Certificate
- ii. Latest Income Certificate (issued on or after 01.04.2024) upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC Certificate
- v. Undertaking (Annexure-XXII of prospectus) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account.”

Fees and dues at the time of admission for SC students who are eligible for Post Matric Scholarship is: **Boys and Girls- Rs. 3870/-**

- ii. Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
