The recommendations of the committee constituted under the chairmanship of Dean, PGS were deliberated upon in detail and the decisions taken as under:

The following shall be substituted in Appendix-I, Table-II of guidelines for filling up of Tabular Summary of Academic Performance Indicator (API) Scores on Performance Based Appraisal System (PBAS), indicating the total score cards for CAS during the assessment period.

Note-1: The maximum score for each activity at every stage of evaluation shall be evenly distributed and every eligible candidate will have to secure the minimum required score on yearly basis except for Publication and Peer Recognition.

Note 2: For Publication and Peer Recognition, cumulative score during the assessment period at each stage of evaluation shall be considered.

For assessment of publications, it was also decided that for the research papers in the referred and non referred journals, maximum marks will be awarded as under:

1 <sup>st</sup> author	=	1.00
2 <sup>nd</sup> and 3 <sup>rd</sup> authors	=	0.75
For rest of the authors	=	0.50
