Subject: - Proposed changes in Prospectus (2022-23) Diploma Courses regarding examination fees.

It is submitted that examination fees is being charged from the students of 1st Year and 2nd Year of IPVS, LUVAS separately as mentioned in Chapter – V of Prospectus (2022-23) Diploma Courses (Page No 35)(copy enclosed). Whereas, Rs 15,000/- being charged from the students of Private affiliated colleges/institutes at the time of counselling which include “University registration-cum-two years’ examination fees”. To keep parity in examination fees being charged from students of IPVS and that of Private affiliated colleges/institutes, it is proposed that Rs 15,000/- being charged from the students of Private affiliated colleges/institutes be treated as “University registration-cum-one year examination fees” and examination fees of Rs 1100/- per student be collected from for the 2nd Year students of Private affiliated colleges/institutes in consolidated form from the respective private affiliated colleges/institutes. Therefore, there is an urgent requirement to issue the amendment in Prospectus (2022-23) Diploma Courses.

Therefore, the following changes is hereby proposed in Diploma Prospectus 2022-23 for consideration and decision of Board of Studies:
