Sir,

A request of Mr. Devesh having admission no. 18VLD917 student of Bhumika Institute of Veterinary Sciences, Sigra, Mahendergarh was received in the o/o Vice-Chancellor, LUVAS in which the applicant has requested to consider his practical examination marks of the subject Elementary Medicine (VLDD-X). In this regard it is submitted that the student was appeared in the annual examination 2021-22. The practical examination of Elementary Medicine (VLDD-X) was held on 02.12.2022 as per examination schedule. The student could not appear in the practical examination of said subject due to severe fever. He came on the next day in the college and requested the principal to conduct his practical examination on 03.12.2022. However, while submitting the practical results by the college to this office the said student was shown absent in Elementary Medicine (VLDD-X). Thereafter, the result of the annual examination was declared on 14.01.2023 in which the student failed in all the three subjects he appeared. The college had requested this office to consider the practical examination result of said student vide their letter no. BCVSRC/2023/08 dated 23.01.2023. The request was considered sympathetically and rejected due to not being covered under university rules. The rule in this regard is as under:

Rule no. 7.8.1 of Rules & Regulations Governing Diploma Courses "Annual examinations of all the VLDD students (LUVAS as well as affiliated private Institutes/ Colleges) will be conducted on the same dates and time as per the common date sheet."

Now the student has requested to the Worthy Vice-Chancellor to consider his practical examination marks of Elementary Medicine (VLDD-X). Vice-Chancellor has directed Director, IPVS to put up the case in Board of Studies for discussion and recommendation.

Keeping in view of the above, it is submitted that the agenda item is submitted to Dean COVS-cum-Chairman Board of Studies for kind consideration and further recommendation of Board of Studies, please.
