In pursuance of the above decision of the Board, the Vice-Chancellor is further pleased to approve the instructions/explanation of the Internal Quality Assurance Cell constituted by him with regard to Academic Performance Indicator (API) criteria based scores on Performance Based Appraisal System (PBAS) for promotion of teachers at various stages under the Career Advancement Scheme (CAS).

Teachers and other academic staff, who become eligible for promotion under Career Advancement Scheme (CAS) as per the above instructions, are required to submit their applications, complete in all respects along with four duly bound sets of reprints of their publications of the relevant period, wherever applicable, as per the requirement under the rules to this office through their respective Heads/ Controlling Officer by 31.01.2014, so that their cases for promotions may be processed. A copy of guidelines for filling up of API scores and minimum academic performance and service requirements for promotion of teachers is enclosed.
